The Institute vide Advt. No. E-II/07/2024 (DR), invited online applications for filling-up 03 posts (02-OBC & 01-EWS) of Medical Officer in Level-10 of Pay Matrix as per 7th CPC for Hospital Cadre, IIT Delhi. The Shortlisting Committee has scrutinized the applications of the applicants in the light of Prescribed Educational and other qualification required and the 'General Terms and Conditions' of the advertisement for this post.

The following essential criteria was mentioned in the advertisement:

### **Essential:**

A recognized MBBS degree qualification included in the First Schedule or Second Schedule or Part II of the Third Schedule (other than licentiate qualifications) to the Indian Medical Council Act, 1956 (102 of 1956). Holders of Educational qualifications included in Part II of the Third Schedule should also fulfil the conditions specified in subsection (3) of section 13 of the Indian Medical Council Act, 1956 (102 of 1956) and including completion of compulsory rotatory internship followed by at least 03 years of experience in a recognized hospital.

## **Desirable:**

- (i) 03 years' work experience in a medical college or large Govt./ recognized private Hospital.
- (ii) M.D. or M.S. in an appropriate branch of Medicine or diploma in the concerned specialty or Super-specialty mentioned in Section-A or Section-B in Schedule-VI of Ministry of Health and Family Welfare notification G.S.R. 272(E) dated 07.04.2022.

#### OR

Postgraduate Diploma in an appropriate branch of Medicine or diploma in the concerned specialty or Super specialty mentioned in Section-A or Section-B in Schedule-VI of Ministry of Health and Family Welfare notification G.S.R. 272(E) dated 07.04.2022, plus at least 01-year experience in a recognized hospital.

(iii) The above qualifications Diploma / MD / MS may preferably be in Medicine/ Chest diseases/ Pediatrics/Obstetrics and Gynaecology/ family medicine/Psychiatry/ others.

# The Shortlisting committee adopted the following criteria for shortlisting:

1. MBBS from Govt./ Indian College + 03 years work experience in Govt. Hospital, College, Large Private Hospital.

OR

MBBS+MD in IIT appropriate branch (Medicine, Pediatrics, Obstetrics and Gynecology, Family Medicine, Emergency Medicine, Respiratory Medicine)

OR

MBBS + Diploma in IIT appropriate branch (Medicine, Pediatrics, Obstetrics and Gynecology, Family Medicine, Emergency Medicine, Respiratory Medicine) 01-year work experience in Govt. Hospital, College, Large Private Hospital.

Based on the adopted criteria mentioned above, **22** applicants have been provisionally shortlisted.

Please note that the Shortlisting for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Experience & Salary etc. which he/she have mentioned in his/her online application. At any stage, if any applicant is found ineligible, his/her candidature for the said post will be treated ascancelled. Verification of documents will be done at later stage in the Selection process. If it is found that applicants have furnished false or wrong information, their candidature will be rejected at any time/ any stage.
