Subject: Regarding recruitment for the post of Physiotherapist at IIT Delhi.

The Institute vide Advt. No. E-II/07/2024 (DR), invited online applications for filling-up 02 posts (01 for male & 01 for female) under UR Category of Physiotherapist in Level-6 of Pay Matrix as per 7th CPC for Hospital Cadre, IIT Delhi. The Shortlisting Committee has scrutinized the applications of the applicants in the light of Prescribed Educational and other qualification required and the 'General Terms and Conditions' of the advertisement for this post.

The following essential criteria were mentioned in the advertisement:

Essential:

Degree in Physiotherapy from a recognized University/ Institute with at least 55% marks with minimum 03 years relevant experience in a recognized Hospital/ Institute/ College.

OR

Diploma in Physiotherapy/ Physio-Occupational Therapy (after 10+2) from a recognized University/ Institute with at least 55% marks with minimum 05 years relevant experience in a recognized Hospital/ Institute/ College.

Based on the criteria mentioned above, **180** applicants have been found suitable {out of which 130 applicants are Shortlisted and 50 applicants are Provisionally Shortlisted (subject to submission of required documents)}.

Please note that the Shortlisting for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Experience & Salary etc. which he/she have mentioned in his/her online application. At any stage, if any applicant is found ineligible, his/her candidature for the said post will be treated as cancelled. Verification of documents will be done at later stage in the Selection process. If it is found that applicants have furnished false or wrong information, their candidature will be rejected at any time/ any stage.

The Institute reserves the right to increase or decrease the number of vacancies, postpone or cancel the recruitment altogether for any of the post advertised above or for all the posts without assigning any reason thereof.
