The Shortlisting Committee has scrutinized the applications of the applicants in the light of Prescribed Educational and other qualification required and the 'General Terms and Conditions' of the advertisement for this post.

The following essential criteria were mentioned in the advertisement:

Essential:

1. (i) B.Sc. (Hons.) Nursing/ B.Sc. Nursing from an Indian Nursing Council recognized Institute or University.

OR

- B.Sc. (Post-certificate)/Post Basic B.Sc. Nursing from an Indian Nursing Council recognized Institute or University.
- (ii) Registered as Nurses & Midwife in State/Indian Nursing Council.

OR

- 2. (i) Diploma in General Nursing Midwifery from and Indian Nursing Council recognized Institute/ Board or Council.
 - (ii) Registered as Nurses & Midwife in State/Indian Nursing Council.
 - (iii) Two years' experience in minimum 50 bedded Hospital after acquiring the educational qualification mentioned above.

Based on the criteria mentioned above, **535** applicants have been found suitable {out of which 245 applicants are shortlisted and 290 applicants provisionally shortlisted (subject to submission of required documents)}.

Please note that the Shortlisting for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Experience & Salary etc. which he/she have mentioned in his/her online application. At any stage, if any applicant is found ineligible, his/her candidature for the said post will be treated as cancelled. Verification of documents will be done at later stage in the Selection process. If it is found that applicants have furnished false or wrong information, their candidature will be rejected at any time/ any stage.

The Institute reserves the right to increase or decrease the number of vacancies, postpone or cancel the recruitment altogether for any of the post advertised above or for all the posts without assigning any reason thereof.
