**Subject:** Regarding recruitment for the post of Assistant Programme Coordinator (Level-10) at IIT Delhi.

The Institute vide Advt. No. E-II/07/2024 (DR) dated March 11, 2024, invited online applications for filling-up 01 post (UR) of Assistant Programme Coordinator in Level-10 of Pay Matrix as per 7th CPC for ETSC, IIT Delhi. The Shortlisting Committee has scrutinized the applications of the applicants in the light of Prescribed Educational and other qualification required and the 'General Terms and Conditions' of the advertisement for this post.

The following essential criteria were mentioned in the advertisement:

**Essential:**

M.Tech. or equivalent with at least 55% marks in the qualifying degree or equivalent with 05 years relevant experience.

**OR**

MCA/M.Sc./B.Tech. with at least 55% marks in the qualifying degree or equivalent with 07 years relevant experience.

**The Committee decided to adopt the following criteria for shortlisting purposes:**

**At least an M.Tech in any Electrical/Electronics Engineering discipline or any Computer Science/Neuro-cognitive Science discipline with at least 55% marks {% marks = CGPA (on a 10-point scale \*10)} with 05 years relevant experience after M.Tech.**

Based on the adopted criteria mentioned above, **23** candidates have been provisionally shortlisted.

Please note that the Shortlisting for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Experience & Salary etc. which he/she have mentioned in his/her online application. At any stage, if any applicant is found ineligible, his/her candidature for the said post will be treated as cancelled. Verification of documents will be done at later stage in the Selection process. If it is found that applicant(s) have furnished false or wrong information, their candidature will be rejected at any time/ any stage.

The Institute reserves the right to increase or decrease the number of vacancies, postpone or cancel the recruitment altogether for any of the post advertised above or for all the posts without assigning any reason thereof.
