**Subject:** Regarding recruitment for the post of Assistant Registrar (Level-10) at IIT Delhi.

The Institute vide Advt. No. Mission Mode (DR) (3) / 2023 dated February 17, 2023, invited online applications for filling-up 08 posts (i.e. 05-UR, 02-OBC, 01-EWS) of Assistant Registrar in Level-10 of Pay Matrix as per 7th CPC for Administration, IIT Delhi. The Shortlisting Committee has scrutinized the applications of the applicants in the light of Prescribed Educational and other qualification required and the 'General Terms and Conditions' of the advertisement for this post.

The following essential criteria was mentioned in the advertisement:

**Essential:**

Master's degree or its equivalent in any discipline from a recognized University with at least 55% marks.

**Experience:**

At least 05 years regular/permanent relevant experience of working under Central / State Governments/ UTs/ their Universities or Institutions/ Autonomous bodies/ Government laboratories/ Statutory organizations/PSU/PSE.

**In addition to Essential Qualification, the Committee decided to adopt the following criteria for shortlisting purposes:**

Considering the diversity of applications received, the Committee decided that at least 05 years regular/ permanent experience, post essential qualification, in Pay Level-6 (7<sup>th</sup> CPC) or equivalent, would be considered as relevant experience.

Based on the adopted criteria mentioned above, **661** applicants have been provisionally shortlisted.

Please note that the Shortlisting for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Experience & Salary etc. which he/she have mentioned in his/her online application. At any stage, if any applicant is found ineligible, his/her candidature for the said post will be treated as cancelled. Verification of documents will be done at later stage in the Selection process. If it is found that applicants have furnished false or wrong information, their candidature will be rejected at any time/ any stage.

The Institute reserves the right to increase or decrease the number of vacancies, postpone or cancel the recruitment altogether for any of the post advertised above or for all the posts without assigning any reason thereof.
