Subject: Regarding recruitment for the post of Assistant Sports Officer at IIT Delhi.

The Institute vide Advt. No. Mission Mode (DR) (2) / 2023 dated February 14, 2023 invited online applications for filling-up 01 post (i.e. 01-UR) of Assistant Sports Officer in Level-06 of Pay Matrix as per 7th CPC for Sports Administration Cadre, IIT Delhi. The Shortlisting Committee has scrutinized the applications of the applicants in the light of Prescribed Educational and other qualification required and the 'General Terms and Conditions' of the advertisement for this post.

The following essential criteria was mentioned in the advertisement:

Essential:

Graduate with Bachelor in Physical Education (B.P. Ed.) or its equivalent with at least 55% marks in the qualifying degree from a recognized University/Institute with at least 02 years of coaching experience in a University/Institute.

Desirable:

- (i) Master of Physical Education with at least one Inter University participation.
- (ii) At least one year experience in Govt. / Autonomous Bodies / or University or College.
- (iii) Computer course in M.S. Word, Excel, etc. from a reputed Institute.

In addition to essential qualification, the Committee decided to adopt the following criteria for shortlisting purposes:

- (i) Sports participation in at least two Inter University / National / International.
- (ii) Relevant experience (i.e., 02 years) in government / government -aided bodies was also considered.
- (iii) Candidates with M.P.Ed. with atleast 01 year of relevant experience (as above) were also shortlisted. (This was mentioned as desirable qualification in the advertisement).

As per Para 6 of the General Instructions of the advertisement, "*In case, applications received are in excess of the number of posts advertised for the vacant posts, the Scrutiny/ Shortlisting Committee may adopt additional/higher criteria for shortlisting, based on academic performance and/ or years of experience of the applicants or it may so decide, and the shortlisted applicants will be called for certain evaluation process and subsequent stage(s) as applicable on qualifying the same as per decision of the Institute*".

Based on the adopted criteria mentioned above, **17** applicants have been provisionally shortlisted.

Please note that the Shortlisting for the above post is “Provisional” and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Experience & Salary etc. which he/she have mentioned in his/her online application. At any stage, if any applicant is found ineligible, his/her candidature for the said post will be treated as cancelled. Verification of documents will be done at later stage in the Selection process. If it is found that applicants have furnished false or wrong information, their candidature will be rejected at any time/ any stage.

The Institute reserves the right to increase or decrease the number of vacancies, postpone or cancel the recruitment altogether for any of the post advertised above or for all the posts without assigning any reason thereof.
