Subject: Shortlisting for the post of Assistant Administrative Officer at IIT Delhi.

The Institute vide No. E-II/01/2026(DR) dated 26.02.2026 (Special Recruitment Drive) had invited online application for filling-up 01 (ST) post of Assistant Administrative Officer reserved for PwBD VI (B, LV) in Level 6 as per 7th CPC for Administration Cadre. Total 22 applications were received for the said post. The Shortlisting Committee has scrutinized the applications of the applicants in the light of prescribed essential educational qualification/experience and the 'General Instructions' of the advertisement for this post.

The following essential criteria were mentioned in the advertisement:

Essential Qualification/ Experience:

Master's degree in any discipline from recognized university with at least 55% marks in qualifying degree with 01 year regular/permanent relevant experience of working under Central/ State Governments/ UTs/ their Universities or Institutions/ Autonomous bodies/ Government laboratories/ Statutory organizations/PSU/PSE.

OR

Bachelor's Degree in any discipline from recognized university with at least 55% marks in qualifying degree with 03 years' regular/permanent relevant experience of working under Central/ State Governments/ UTs/ their Universities or Institutions/ Autonomous bodies/ Government laboratories/ Statutory organizations/PSU/PSE.

Based on the criteria mentioned above, **13** applicants have been provisionally shortlisted, and 09 applicants found not shortlisted.

However, Para 8.5 of DoPT OM No. No.36035/02/2017-Estt (Res) dated 15.01.2018 shall be applicable for the said post.

Please note that the Shortlisting for the above post is "Provisional" and is subject to verification of original certificates/ documents pertaining to his/her Educational Qualification, Marksheet, Experience & Salary etc. which he/she has mentioned in his/her online application. At any stage, if any applicant is found ineligible, his/her candidature for the said post will be treated as cancelled. Verification of documents will be done at later stage in the Selection process. If it is found that applicant(s) have furnished false or wrong information, their candidature will be rejected at any time/ any stage.

The Institute reserves the right to increase or decrease the number of vacancies, postpone or cancel the recruitment altogether for any of the post advertised above or for all the posts without assigning any reason therefor.
