KEY OBJECTIVES

- 1. The aim is to procure Smart Boards (55 inches-86 inches) for teaching learning purpose.
- 2. The smart boards should have the palm rejection feature.
- 3. The smart boards should support both stylus pen and finger gestures recognition and control.
- 4. The hardware and software supplied shall be under comprehensive insurance for a period of 5 years from the date of installation.

EVALUATION CRITERIA

- Interested applicants shall submit a proposal with maximum two best technological smart boards. Full specification of the article quoted for shall be submitted in PDF form along with illustrated pamphlets, brochures etc.
- Only shortlisted vendors will be intimated for the detailed technical presentation as well as for the demonstration of products to an IIT Delhi committee sometime between September 5th and October 31st, 2024.
- A committee will evaluate each product and have a subsequent discussion. Note that the committee has full discretion in such matters. It will evaluate the suitability of the product keeping the institution's educational requirements in mind. If it feels that the product is not suitable, then the period of discussion will be very short.
- The product offered shall confirm to the specifications as given in scope of work and shall be guaranteed against defective design, defective quality material supplied, manufacturing defects etc., for a minimum period of 12 months from the date of supply.
- Proper servicing, whenever necessary, has to be provided by the supplier or their authorized agents. Availability of technical support & servicing facility locally/nationally should be indicated.
