(W 425 mm D 450 mm H 185 mm or above)
2. Gas supply/Gas channel
(2 pcs. needle valves)
3. Connections plasma system
(230V/16A, gas: 6 mm)
4. Vacuum chamber/Recipient
(round, borosilicate glass, cap, dia. approx. 105 mm, length: approx. 300 mm, chamber volume : approx. 2.6 liter)
5. Standard electrode
(aluminium/stainless steel, outside the chamber)

7. Generator with 13.56 MHz, 0-50 W, fixed matching
8. Timer analog with/without display
