Sealed quotations are invited for purchase of Long path Gas cell for Thermo Scientific FT-IR (Model: Nicolet 6700) along with standard parts-Qty-One No. Technical specification is mentioned below.

### Technical Specifications

#### Long path length Gas Cell

1. Long path (minimum path length 10 m) preferably variable path length and with optional heating assembly
2. Borosilicate or stainless steel body material
3. Optics : optics with protected gold coating
4. Operable from vacuum to ambient pressure
5. Windows should be replaceable & with ZnSe windows or anti-reflective coated ZnSe windows
6. Valve/gauge assemblies : with ¼” Swagelok valves
7. Should be compatible with existing Thermoscientific FT-IR (Nicolet 6700 model)
8. Mounting : Vertical/ Horizontal please mention (Vertical is preferable)

#### Please mention other parts and hard ware

#### Necessary Terms and Conditions:

- A. IIT Delhi is exempted from paying custom duty under notification No.51/96 (partially or fully) and necessary “Custom Duty Exemption Certificate” can be issued after providing following information.
  - a. Shipping details i.e. Master Airway Bill No. and House Airway No. (if exists)
  - b. Forwarder details i.e. Name, Contact No., etc.

Custom Duty Exemption Certificate will be issued to the shipment in the name of the Institute and Bills of Entry should be submitted to IIT Delhi later on.

- B. Either the Indian agent on behalf of the Principal/OEM or Principal/OEM itself can bid but both cannot bid simultaneously for the same item/product in the same tender. If an agent submits bid on behalf of the Principal/OEM, the same agent shall not submit a bid on behalf of another Principal/OEM in the same tender for the same item/product.
- C. IIT Delhi is exempted from paying Excise Duty and necessary Excise Duty Exemption Certificate will be provided for which following information is required.
- a. Quotation with details of Basic Price, Rate & Amount on which ED is applicable.
- D. Imported items should be quoted on FOB basis (Freight on Board) and FOB price be Provided.
- E. Please mention the warranty period and also AMC/service should be available least 5 years after the post warranty period, please mention it sparely.
- F. Payment Options
- i. **Letter of Credit:** 90% payment against shipping documents & balance 10% after satisfactory installation. For large purchase i.e. costing over Rs. 1 crore, 100% payment be made through LC.
  - ii. **Sight Draft:** Payment against documents through bank.
  - iii. **Against Delivery:** Payment by wire transfer after receipt of material.
  - iv. **Advance payment:** pre-payment by wire transfer (for orders less than Rs. 5 lakh) for items proprietary in nature.
