
- (iii) Tenders shall be accompanied with Earnest money of Rs. 113416.00 in the form of Banker's cheque or Demand draft or fixed deposit receipt of a schedule bank drawn in favour of Registrar, I.I.T. Delhi.
- (iv) Attested valid TIN Registration Certificate under D-VAT including deposit receipt.
- (v) Completion certificates issued by an officer not below the rank of Executive Engineer of similar works completed by the Agency.
- (vi) Attested copy of registration certificates to be submitted. Registration of firms/ Contractors must be valid on the last day of issue of Tenders or extended date of issue of Tenders.
- (vii) Work means only work under Government/ Public Sector Under taking / Autonomous bodies.
- (viii) Similar work means work pertaining to works of maintenance of buildings/ Renovation/ Addition Alteration/ Rehabilitation/ New construction of buildings (Civil works).
