3. The quotation must have a validity of at least three months.

4. If the quotation is submitted by representative of Principals / Manufacturers, a valid Agency / Dealership Certificate of the latest date should be enclosed. Else the bid will be rejected.
5. Quotation must give a delivery schedule in the Technical Bid, which in no case should exceed 3 weeks from the date of placement of order.
6. Incomplete quotations will be summarily rejected.
7. The Institute reserves the right to accept or reject any or all of the quotations without assigning any reasons.
8. All applicable taxes must be clearly mentioned.
9. Payment will be made as per IIT norms after delivery. Advance payment is not allowed.
