#### INSTRUCTIONS FOR ONLINE BID SUBMISSION

As per the directives of Department of Expenditure, this quotation / tender document has been published on the Central Public Procurement Portal (URL: <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a>). The bidders are required to submit softcopies of their bids electronically on the CPP portal, using valid Digital Signature Certificates (DSC). The instructions given below are meant to assist the bidders in registering on the CPP portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP portal.

More information useful for submitting online bids on the CPP portal may be obtained at <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a>

#### REGISTRATION

- 1. Bidders are required to enrol on the e-procurement module of the Central Public Procurement portal (URL: <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a>) by clicking on the link, "click here to enrol". Enrolment on the CPP portal is free of charge.
- 2. As part of the enrolment process, the bidders will be required to choose a unique user name and assign a password for their accounts.
- 3. Bidders are advised to register their valid e-mail address and mobile number as part of the registration process. These would be used for any communication from the CPPPortal.
- 4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (class 2 or class 3 certificates with signing key usage) issued by any certifying authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.) with theirprofile.
- 5. Only one valid DSC should be registered by a bidder. Please note that bidders are responsible to ensure that they do not lend their DSCs to others which may lead tomisuse.
- 6. Bidder then logs into the site through the secured log-in by entering their user ID/passwordandthepasswordoftheDSC/e-Token.

#### SEARCHING FOR TENDER DOCUMENTS

- 1. There are various search options built in the CPP portal to facilitate bidders to search active tenders by several parameters. These parameters could include tender ID, organization name, location, date, value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a tender published on the CPP portal.
- Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. The tenders can be moved to the respective "My Tenders" folder. This would enable the CPP portal to intimate the bidders through SMS / email in case there is any corrigendum issued to the tenderdocument.
- 3. The bidder should make a note of the unique Tender ID assigned to each other, incasetheywanttoobtainanyclarification/helpfromtheHelpdesk.



#### PREPARATION OF BIDS

- 1. Bidder should take into account any corrigendum published on the tender document before submitting theirbids.
- 2. Please go through the tender advertisement and the tender document carefully tounderstand the documents required to be submitted as part of the bids. Please note the number of covers in which the bid documents have to be submitted. Any deviations from the semay lead to rejection of the bids.
- 3. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can bein PDF/ XLS / RAR / DWF formats. Bid documents may be scanned with 100 dpi with black & white option.
- 4. To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor's certificates, etc.) has been provided to the bidders. Bidderscan use "My Space" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submittinga bid, and need not be uploaded again and again. This will lead to a reduction inthe time required for bid submission process.

#### **SUBMISSION OF BIDS**

- 1. Bidder should log into the site well in advance for bid submission so thathe / sheupload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due toother issues.
- 2. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tenderdocument.
  - 3. Bidder has to select the payment option as "on-line" to pay the tender fee / EMD as applicable and enter details of the instrument. Whenever, EMD / Tender fees is sought, bidders need to pay the tender fee and EMD separately on-line through RTGS (Refer to Schedule, Page no. 4)
  - 4. A standard BOQ Format has been provided with the tender document to be filled by all the bidders. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. Bidders are required to download the BOQ file, open it and complete the white colored [unprotected] cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

OR

In some cases financial bids can be submitted in PDF format as well (in lieu of BOQ).

5. The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.



- 6. All the documents being submitted by the bidders would be encryptedusing PKIencryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bitencryptiontechnology. Datastorage encryption of sensitive fields is done.
- 7. The uploaded tender documents become readable only after the tender opening by the authorized bidopeners.
- 8. Upon the successful and timely submission of bids, the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date &time of submission of the bid with all other relevant details.
- 9. Kindly add scanned PDF of all relevant documents in a single PDF file of compliancesheet.

- 1. The successful bidders shall be required to submit a performance guarantee of 5% of the tendered amount in the form of Bank Guarantee or F.D.R. from a Nationalized / Scheduled Bank within 15 days of issue of letter of intent before award of work. In case of failure by the Contractor to submit the performance guarantee within the specified period, full earnest money will be forfeited and the tender shall be treated as null and void. The performance guarantee shall be initially valid up to the stipulated date of completion plus 60 (Sixty) days beyond that.
- 2. Contractors who fulfill the following requirements shall be eligible to apply. Joint ventures are notaccepted.
  - a. Should have satisfactorily completed the works as mentioned below during the last Seven years ending **previous day of last date of submission of bids.**

- 3. The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of submission of financialbid.



- 4. Similar work means: Maintenance work of Outdoor and Indoor Telephone Network in Government / Public Sector Undertaking / Central Autonomous bodies.
- **5.** Work means work done under Government / Public Sector Undertaking / Central Autonomousbodies.
- **6.** Completion certificates are required to be got issued by an officer not below the rank of **Executive Engineer (E)** of similar works completed by the Firm. The work experience certificates submitted by the bidders shall clearly indicatethat:
  - a. The similar work executed shall be as per '4'above
  - b. The completed cost of thework
  - c. Actual date of completion of thework
- 7.IITD is committed to follow the principle of transparency, equity and competitiveness in public procurement. Before submission of bid, each bidder should sign integrity pact at respective places and submit the bid. If duly signed integrity pact is not submitted by bidder, such bid shall not beconsidered.
- 8. The intending bidder must read the terms and conditions [both commercial & Additional] & IITD 6 carefully which will be the part of the Contract. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- 9. Information and Instructions for bidders posted on website shall form part of biddocument.
- **10.**The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website e-procure.gov.in free ofcost.
- 11. But the bid can only be submitted after depositing requisite EMD as specified in the "Schedule".
- **12.**Copy of all mandatory documents as desired in the NIT shall be scanned and up-loaded to the e-Tendering website within the period of bid submission. However, certified / original copy of all the scanned and up-loaded documents shall have to be submitted by the lowest bidder only within a week physically in the office of e-tendering authority, if so desired, by the tender inviting authority.
- **13.**Online bid documents submitted by intending bidders shall be opened only of those bidders, who has deposited requisite EMD / attached scanned copy and other documents scanned and uploaded are found inorder.
- **14.** Those contractors not registered on the website mentioned above, are required to get registered beforehand. Bidders should refer "Instruction for Online Bid Submission" given earlier for further assistance.
- **15.**When bids are invited in two / three stages systems and if it is desired to submit revised financial bid it shall be mandatory to submit revised financial bid. If not submitted then the bid submitted earlier shall become invalid.
- 16. The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid downcriterion.
- 17. Contractors must ensure to quote rate of eachitem.
- 18. 'Class 1 Local Supplier' means a supplier or service provider, whose goods, services or works offered for procurement has local content equal to or more than 50% as defined under Order No. P-45021/2/2017-PP(BE-II) dated 04-06-2020 issued by Department for Promotion of Industry and Internal Trade (Public Procurement Section), Ministry of Commerce and Industry, Govt. of India.
  - a. 'Local Content' means the amount of value added in India which shall unless and otherwise prescribed by the nodal ministry, be the total value of the item procured (excluding net domestic indirect taxes) minus the value of imported content in the item (including all domestic duties) as a proportion of the total value, inpercent.
  - b. For the purpose of verification of 'Local Content', the Class-1 Local Supplier / Service Provider at the time of bidding, tender or solicitation shall be required to indicate percentage



- of local content and provide self-certification that the items offered meet the local content requirement for Class 1 Local Supplier. They shall also give details of the location(s) at which the local value addition is made.
- c. In cases of procurement for a value in excess of 10 crore, the Class 1 Local Supplier shall be required to provide a certificate from the statutory auditor or cost auditor of the company (in case of the companies) or from a practicing cost accountant or practicing chartered accountant (in respect of suppliers other than companies) giving the percentage of local content.
- d. Nodal Ministries may constitute committees with internal and external experts for independent verification of self-certifications and auditor's / accountant's certificates on random basis and in the case of complaints.
- e. False declarations will be in breach of Code of Integrity under rule 175(1)(i)(h) of the General Financial Rules for which a bidder or its successors can be debarred for upto two years as per Rule 151 (iii) of the General Financial Rules along with such other actions as may be permissible underlaw.

- 1.1 The work is estimated to cost Rs.37,60,112.00. This estimate, however, is given merely as a rough guide
- 1.2 Intending bidder is eligible to submit the bid provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below:-

# 1.2.1 Criteria of eligibility for submission of bid documents: Conditions for intending bidders /contractors:

**1.2.1.1 Three** similar works each of value not less than **Rs. 15,04,045.00** or **two** similar work each of value not less than **Rs. 22,56,067.00** or **one** similar work of value not less than **Rs. 30,08,090.00** during last 7 years endingprevious day of last date of submission of bids. The value of executed work shall bebrought to currentcosting level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of submission of financial bid.

#### 1.2.2 To become eligible for issue of bid, the bidders shall have to furnish an affidavit as under:

- "I / We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I / we shall be debarred for bidding in IIT Delhi in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee (Scanned copy to be uploaded at the time of submission of bid)"
- **2.** Agreement shall be drawn with the successful bidders on prescribed Form No. IITD 7/8 which is available as IIT Delhi Publication. Bidders shall quote their rates as per various terms and conditions of the said form which will form part of the agreement.
- 3. The time allowed for carrying out the work will be 12 Months from the date of start as defined in schedule 'F' or from the first date of handing over of the site, whichever is later, in accordance with the phasing, if any, indicated in the bid documents.
- **4.** The site for the work is available.

Kindly refer to the UTR Column of the Declaration Sheet at Annexure-1). **OR** In the form of Banker's Cheque or Demand Draft or FDR of scheduled bank in favor of **Registrar, IITDelhi** (scanned copy of the same to be uploaded with the bid, date of issue shall be within the NIT period) Interested contractor who wish to participate in the bid has to ensure payment of EMD within the period of bidsubmission.

- 9.1 Copy of all 'mandatory documents' and other documents as specified in the press notice shall be Scannedand uploaded to the e-tendering website within the period of bid submission. However, certified copy of allthe scanned and uploaded documents along with original EMD (of scanned copy) as specified in pressnotice shall have to be submitted by the lowest bidder only within a week physically in the office of tenderopening authority.

#### **Preamble**

WHEREAS the Principal / Owner has floated the Tender (NIT No. 9861/44/EW/IITD/2020-21) (hereinafter referred to as "Tender/Bid") and intends to award, under laid down organizational procedure, contract for "A.R & M.O Telephone Exchange at IIT Delhi. Sub-Head:- Maintenance of Outdoor and Indoor Telephone Network..." (Name of work) hereinafter referred to as the "Contract".

AND WHEREAS the Principal/Owner values full compliance with all relevant laws of the land, rules, regulations, economic use of resources and of fairness/transparency in its relation with its Bidder(s) and Contractor(s). AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement (hereinafter referred to as "Integrity Pact" or "Pact"), the terms and conditions of which shall also be read as integral part and parcel of the Tender/Bid documents and Contract between the parties.

NOW, THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as under:

#### **Article 1: Commitment of the Principal / Owner**

- 1) The Principal/Owner commits itself to take all measures necessary to prevent corruption and to observe the following principles:
  - (a) No employee of the Principal / Owner, personally or through any of his / her family members, will inconnection with the Tender, or the execution of the Contract, demand, take a promise for or accept, forself or third person, any material or immaterial benefit which the person is not legally entitled to.
- (b) The Principal/Owner will, during the Tender process, treat all Bidder(s) with equity and reason. The Principal/Owner will, in particular, before and during the Tender process, provide to all

- (c) The Principal/Owner shall Endeavour to exclude from the Tender process any person, whose Conductin the past has been of biased nature.
  - 2) If the Principal/Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal code (IPC)/Prevention of Corruption Act, 1988 (PoC Act) or is in violation of the principles herein mentioned or if there be a substantive suspicion in this regard, the Principal/Owner will inform the Chief Vigilance Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

#### **Article 2: Commitment of the Bidder(s) / Contractor(s)**

- 1) It is required that each Bidder/Contractor (including their respective officers, employees and agents) adhere to the highest ethical standards, and report to the Government / Department all suspected acts of fraud or corruption or coercion or collusion of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.
- 2) The Bidder(s)/Contractor(s) commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:
  - a) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm, offer, promise or give to any of the Principal/Owner's employees involved in the Tender process or execution of the Contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the Tender process or during the execution of the Contract.
  - b) The Bidder(s)/Contractor(s) will not enter with other Bidder(s) into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to cartelize in the bidding process.
  - c) The Bidder(s) / Contractor(s) will not commit any offence under the relevant IPC/PoC Act. Further the Bidder(s) / Contractor(s) will not use improperly, (for the purpose of competition or personal gain), or pass on to others, any information or documents provided by the Principal / Owner as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
  - d) The Bidder(s) / Contractor(s) of foreign origin shall disclose the names and addresses of agents / representatives in India, if any. Similarly Bidder(s) / Contractor(s) of Indian Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participate in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent/parallel tender for the same item.
  - e) The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.
- 3) The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- 4) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm indulge in fraudulent practices means a willful misrepresentation or omission of facts or submission of fake/forged documents in order to induce public official to act in reliance thereof, with the purpose of obtaining unjust advantage by or causing damage to justified interest of others and/or to influence the procurement process to the detriment of the Government interests.
- 5) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision



through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may befall upon a person, his/ her reputation or property to influence their participation in the tendering process).

#### **Article 3: Consequences of Breach**

Without prejudice to any rights that may be available to the Principal /Owner under law or the Contract or its established policies and laid down procedures, the Principal/Owner shall have the following rights in case of breach of this Integrity Pact by the Bidder(s)/Contractor(s) and the Bidder/ Contractor accepts and undertakes to respect and uphold the Principal/Owner's absolute right:

- 1) If the Bidder(s)/Contractor(s), either before award or during execution of Contract has committed a transgression through a violation of Article 2 above or in any other form, such as to put his reliability or credibility in question, the Principal/Owner after giving 14 days notice to the contractor shall have powers to disqualify the Bidder(s)/Contractor(s) from the Tender process or terminate/determine the Contract, if already executed or exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/Owner. Such exclusion may be forever or for a limited period as decided by the Principal/Owner.
- 2) **Forfeiture of EMD/Performance Guarantee/Security Deposit**: If the Principal/Owner has disqualified the Bidder(s) from the Tender process prior to the award of the Contract or terminated/determined the Contract or has accrued the right to terminate/determine the Contract according to Article 3(1), the Principal/Owner apart from exercising any legal rights that may have accrued to the Principal/Owner, may in its considered opinion forfeit the entire amount of Earnest Money Deposit, Performance Guarantee and Security Deposit of the Bidder/Contractor.
- 3) **Criminal Liability**: If the Principal/Owner obtains knowledge of conduct a Bidder or Contractor, or of an employee or a representative or an associate of a Bidder or Contractor which constitutes corruption within the meaning of IPC Act, or if the Principal / Owner has substantive suspicion in this regard, the Principal/Owner will inform the same to law enforcing agencies for further investigation.

#### **Article 4: Previous Transgression**

- 1) The Bidder declares that no previous transgressions occurred in the last 5 years with any other Company in any country confirming to the anticorruption approach or with Central Government or State Government or any other Central/State Public Sector Enterprises in India that could justify his exclusion from the Tender process.
- 2) If the Bidder makes incorrect statement on this subject, he can be disqualified from the Tender process or action can be taken for banning of business dealings/ holiday listing of the Bidder/Contractor as deemed fit by the Principal/ Owner.
- 3) If the Bidder/Contractor can prove that he has resorted / recouped the damage caused by him and has installed a suitable corruption prevention system, the Principal/Owner may, at its own discretion, revoke the exclusion prematurely.

#### **Article 5: Equal Treatment of all Bidders/Contractors/Subcontractors**

- 1. The Bidder(s)/Contractor(s) undertake(s) to demand from all subcontractors a commitment in conformity with this Integrity Pact. The Bidder/Contractor shall be responsible for any violation(s) of the principles laid down in this agreement/Pact by any of its Sub-contractors/sub-vendors.

#### **Article 6: Duration of the Pact**

However, nothing extra shall be paid on account of these additional specification and conditions, as the same are to be read along with schedule of quantities for the work.
- 1.4The Tender should in his own interest visit the site and get familiarize with the site conditions before tendering.
- 1.5No T&P shall be issued by the Department and nothing extra shall be paid on account of this.

#### 2 COMMERCIAL CONDITIONS

#### 5. Performance Guarantee

# SPECIAL TERMS AND CONDITIONS

- 1. That it is expressly understood and agreed between the parties to this Agreement that the persons deployed by the contractor for the services mentioned above shall be the employees of the contractor for all intents and purposes and that the persons so deployed shall remain under the control and supervision of the contractor and in no case, shall a relationship of employer and employee between the said persons and the IITD shall accrue/arise implicitly or explicitly.
- 2. That on taking over the responsibility of providing Contractor's Worker, the contractor shall formulate the mechanism and duty assignment under intimation to the Engineer-in-charge. Subsequently, the contractor shall review work arrangement from time to time. The contractor shall further be bound by and carry out the directions/instructions given to him by the Engineer-in-charge in this respect from time to time.
- 3. That the Engineer-in-charge or any other person authorized by him shall be at liberty to carry out surprise check on the persons so deployed by the contractor in order to ensure that persons deployed by him are doing their duties.
- 4. That in case of the persons so deployed by the contractor does not come up to the mark or does not perform his/her duties properly or indulges in any unlawful activities or riots or disorderly conduct, the contractor shall

- immediately withdraw and take suitable action against such persons on the report of the Engineer-in-charge. Further, the contractor shall immediately replace the particular person so deployed on the demand of the Engineer-in-charge, in case of any of the aforesaid acts on the part of the said person.
- 5. That the contractor shall particularly abide by the provisions of Minimum Wages Act, 1948. Minimum wages shall be paid by the Agency / Contractor at the rate fixed by Delhi Govt. / IIT Delhi from time to time to 5 Nos. qualified trained skilled Mechanics @ Rs.689/- per day, 1 No. Guttiman @ Rs.626/- per day, 5 Nos. Helper @ Rs.569/- per day -, 01 No. Graduate Computer Operator @ Rs.751/- per day and 1No. Network Engineer @ Rs.751/- per day . Arrears, if due as result of increase in minimum wages would be reimbursed to the contractor on submission of proof of actual payment to the worker. In case of half yearly increase in Minimum wages by the Govt. of NCT of Delhi, the contractor will submit copy of gazette notification to the Institute and the same may be considered by the Institute.
- 6. The contractor shall take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct or acts of his employees so deployed.
- 7. Maintenance Engineer for Telephone network should have Diploma in Networking / Electronic & Communication, Electrical, Mechanical, Computer or similar stream from reputed college / institute and Mechanic should be passed Metric with 2 years ITI course or Inter with 2 years ITI course. in Electrical/Electronic/Instrument Mechanic / Wire man / Mechanical / Computer and 1 No.Computer Operator. He / She should have passed graduation and Knowledge of computer application. The contractor shall take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct or acts of his employees so deployed.
- 8. That the contractor shall deploy his persons in such a way that they get weekly rest. The working hour / leave, for which the work is taken from them, do not violate relevant provisions of the Act. The contractor shall in all dealings with the persons in his employment have due regard to all recognized festivals, days of rest and religious or other customs. No extra payment shall be made by the IITD in this regard.
- 9. The Work is to be carried out for stipulated period of time and may be extended further as desired by Engineer-in-charge.
- 10. That the contractor shall keep the IITD indemnified against all claims whatsoever in respect of the employees deployed by the contractor. In case any employee of the contractor so deployed enters in dispute of any nature whatsoever, it will be the primarily responsibility of the contractor to contest the same. In case IITD is made party and is supposed to contest the case, IITD will be reimbursed for the actual expenses incurred towards Counsel Fee and other expenses which shall be paid in advance by the contractor to IITD on demand. Further, the contractor shall ensure that no financial or any other liability comes on IITD in this respect of any nature whatsoever and shall keep IITD indemnified in this respect.
- 11. Non Judicial stamp paper worth Rs.10/- (Ten Rupees only) will be submitted by the contractor which will have to be signed as token of acceptance.
- 12. Institute reserves the right to remove any person deployed by the firm, without assigning any reason/notice. This will be without prejudice to the right of the contractor to remove any of his own employees deployed in the Institute.
- 13. That the contractor shall submit detail of the names, present residential address, age, educational qualifications, experiences, etc. with photocopies of documents of the persons deployed by him in the premises of the IIT Delhi for the purpose of proper identification & category of the employees of contractor deployed at various points/sections. He shall issue identity cards bearing their photographs / identification, etc. and such employees shall display their identity cards at the time of duty.
- 14. The contractor shall ensure that the persons are punctual and disciplined and remain vigilant in performance of their duty.



- 15. The Institute can increase or decrease the manpower requirement in case there is a further increase or decrease in area to be maintained. The increase/decrease in manpower would accordingly affect the billing on pro-rata basis.
- 16. That the contractor shall be required to maintain permanent attendance register in addition to Biometric Attendance(Face detection type provided by IIT Delhi)at the IITD premises which shall be open for inspection and checking by the authorized officers of the IITD.
- 17. The contractor shall be responsible for any injury or accident to the labour during maintenance work and no claim shall be given by the Institute.
- 18. All staff to be deployed by the contractor will be interviewed by the Engineer-in-Charge or his representative before their deployment for the above job only after assessing the capabilities and positive attitude towards the work, the staff will be allowed to work at the work premises.
- 19. Any damage caused to E.I or the equipment or any Institute property during maintenance work shall be made good by the contractor at his own cost.
- 20. The material required for the maintenance of this work shall be supplied departmentally and No T&P will be issued to the contractor.
- 21. Log book as required shall be maintained at site by the contractor.
- 22. The contractor/his supervisor shall visit daily to the Telephone Services Office and will report to AE(T)/AEE(T).
- 23. In case of any dispute, the arbitratorshall be appointed by the Director, IIT Delhi and his decision shall be final as well as binding on both the parties.
- 24. Dismantled material shall be returned to AE(T)/AEE(T) of Telephone Exchange, IIT Delhi.
- 25. Log Books [as prescribed by Engineer-in-charge] and pens required at site of operation of Telephone Exchange maintenance shall be supplied and to be maintained at site by the contractor. Stationary items required for submitting daily/monthly reports, time to time shall be provided by the contractor.
- 26. The contractor shall provide all necessary superintendence during execution of the work and all along thereafter as may be necessary for proper fulfilling of the obligation under the contract.

- 28. Failure to comply any of the clauses(s) or due to unsatisfactory performance as observed by Engineer-incharge, the contract shall be terminated at any stage without assigning any reason.
- 29. That the contractor shall make the payment of wages [not less than minimum wages as & when declared by the Govt. Of NCT Delhi], etc. to persons so deployed monthly basis through Bank Transfer / electronic mode on or before 10th day of every month. Wages shall include bonus @ 8.33% and other allowances of daily wage of the particular worker multiplied by number of days' work actually performed by the worker in a particular month, which shall also be shown separately on the wage sheet of the worker.
- 30. A consolidated wage sheet containing the names of all workers so deployed by the contractor duly signed / acknowledged by the workers after disbursal of wages to be submitted to the Engineer-in charge every month. Proof of disbursal of wages to be submitted before claiming bill. The wage sheet shall contain mandatory fields as per following: [1] Sr. No., [2] Name of the worker, [3] Actual days of duty performed,



- [4] Total wages, [5] Bonus amount, [6] EPF contribution, [7] ESI Contribution, [8] Total deductions, [9] Net wages received / disbursed.
- 31. In case of delay of payment of wages beyond 10 days as specified, IIT Delhi shall arrange for payment to the workers at the risk & cost of the contractor. Decision of the Engineer-in-charge in this regard shall be full & final and binding upon the contractor.
- 32. Attendance comparative sheet shall be prepared by the contractor and to be submitted to the Engineer-incharge after completion of every month as per duty chart, desired days of duty of a particular worker allowing weekly off and actual days of duty performed by the said worker. Summation of the two columns should tie in normal case. Falling short of days of attendance from desired days of attendance shall be got deducted from the bill of the contractor at the rate of the wages given to either operator [in case of operators], helper [in case of helper], Computer operator [in case of Computer operator], Network Engineer [in case of Network Engineer] and Gittiman [in case of Gittiaman], plus. Rs. 300/- per Network Engineer, plus. Rs. 250/- per Computer operator and Mechanic, Rs. 200/- per Gittiman, Rs. 150/- per helper additionally.
- 33. EPF & ESI contribution in respect of the workers shall be deposited with the authority concerned in time and employer's share shall be got reimbursed to the contractor by IIT Delhi on production of proof of deposition.
