**NOTICE INVITING QUOTATIONS**

**Subject:** *High end workstation with GPU card(s) and dual monitors*

Sealed quotations in two-bid (**Technical and Commercial in separate sealed envelopes**) are invited for the purchase of a “*High end workstation with GPU card(s) and dual monitors*” as per the details given below, by **14<sup>th</sup> January, 2014**. to the undersigned. Your quotation should be superscribed “**Technical/Commercial Quotation for High end workstation with GPU cards and dual monitors**” due on **14<sup>th</sup> January, 2014**.

A list of customers in India & Abroad must be enclosed with the technical bid. Further at least two *customer approval certificates* from customers (preferably in India) must be enclosed.

**SPECIFICATIONS FOR “High end workstation with GPU card(s) and dual monitors”**

- **Processor:** Dual processor CPU with 12 cores each or more. (**Intel® Xeon® Processor E5-2697 v2** or better)
- **HDD:** 4 x 2 TB SATA Hard Drive (7200 RPM)
- **Memory:** 128 GB DDR3 ECC 1866 MHz Memory (quote for 256GB separately)
- **GPU Card:** NVIDIA Tesla® K20C GPU card or better (also quote for two cards)
- **Monitor:** 2 x 21.5” LED Full HD Screen Monitor (two monitors)
- **Ports:** At least 10 External USB Ports with minimum 4 no's USB 3.0 Ports, Minimum 1 Integrated Serial Port, 1 RJ- 45, Audio in/out
- **Audio:** Integrated HD Audio with inbuilt Speaker
- **Environmental Compliance:** Energy Star 5.0, EPEAT, CECP (Certificate to be Attached with Technical Bid)
- **Warranty:** 3 Years Comprehensive Onsite (Parts + Labor) with 24 X 7 Technical Supports from the OEM

1) **Other Terms & Conditions:**

- **Validity of the quotation required:** 90 days
- **Warranty:** 01year (*also quote separately for extended warranty for 3 years*)
- **Payment:** 100% on commissioning (preferred)
- Installation, commissioning and staff training expenses are to be borne by the supplier.
- If the above system is a proprietary item then a Proprietary Certificate should be enclosed.
- The Bidder should be ISO Certified (Copy of ISO Certificate should be enclosed).
- The Delivery schedule shouldn't exceed 5 weeks from the date of placement of order.
- The Workstation & Monitor must be from the same OEM .The model no. must be mentioned with the technical datasheet.
- If there is any Indian agent associated with the foreign supplier, then an appropriate "Letter of Authorization" certificate has to be provided with the quotation.
- Further, if the Indian agent quotes for the above mentioned item on behalf of the foreign supplier, then the Indian agent should be enlisted with the Department of Expenditure, Ministry of Finance (Government of India). Copy of the supporting documents has to be enclosed with the quotation. Further, in the letter it must be clearly stated from the principles that the bidder is an authorized agent.
- **Penalty Clause:** If the material not received in stipulated time deduction will be made @ 1% per week from the total value.
- **Rs. 1,00,000/-, in favour of Registrar, IIT Delhi, as earnest money, in the form of A/c Payee Demand Draft/ Fixed Deposit receipt/ Banker's Cheque or Bank Guarantee from any of the commercial banks in an acceptable form should accompany the technical bid.**
