The successful tenderer shall be required to submit a performance guarantee of 5% of the tendered amount in the form of Bank Guarantee or F.D.R. from a Nationalized/Scheduled Bank within 15 days of issue of letter of intent before award of work. In case of failure by the Contractor to supply the performance guarantee within the specified period, full earnest money will be forfeited and the tender shall be treated as void. The performance guarantee shall be initially valid up to the stipulated date of completion plus 60 (Sixty) days beyond that.

2. Applications in person for issue of tenders should accompany the following: -

- i) Firms/ Contractors must have completed satisfactorily one similar work of value not less than Rs. 9,43,100.00 or two similar works each of value not less than Rs. 7,07,400.00 or three similar works each of value not less than Rs. 4,71,600.00 during last 7 years ending on date 30/06/2012 for the subject work.
- ii) Cost of tender **Rs. 500.00 (Rs. Five Hundred)** in cash deposit in S.B.I. or Canara Bank at I.I.T. Delhi (Non-refundable).
- iii) Tenders shall be accompanied with **Earnest money of Rs. 23,579.00** in the form of Banker's cheque or Demand draft or fixed deposit receipt of a schedule bank drawn in favour of I.I.T. Delhi.




- iv) Attested valid TIN Registration Certificate under D-VAT including deposit receipt.
- v) Completion certificates issued by an officer not below the rank of Executive Engineer of similar works completed by the Agency.
- vi) Attested copy of registration certificates to be submitted. Registration of firms/ Contractors must be valid on the last day of issue of Tenders or extended date of issue of Tenders.
- vii) Work means only work under Government/ Public Sector Under taking / Autonomous bodies.
- viii) Similar work means work pertaining to works of thermoplastic road marking paint work.
- ix) Work will allowed to be executed by fully automatic thermoplastic paint applicator machine, for which tenderer shall have to submit an affidavit of owning/ hiring at least one no. of fully automatic thermoplastic paint applicator machine along with application form.
- x) Tenders shall be submitted in the prescribed manner in Sealed Cover.
- xi) Telegraphic, Postal & Conditional tenders are liable to be summarily rejected.
- xii) The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum calculated from the date of completion to last date of receipt of application for tender.
- xiii) IITD is committed to follow the principle of transparency, equity and competitiveness in public procurement. Before submission of bid each bidder should sign integrity pact at respective places and submit the bid if duly signed integrity pact is not submitted by bidder such bid shall not be considered.
