3. If the quote is submitted by the representative of Principals/Manufacturers, a Valid Agency ship/ Dealership Certificate should be enclosed **specific to this tender** at a recent date in original.
4. The Bidder should be ISO Certified (Copy of ISO Certificate should be enclosed).

Envelop B: Financial Bid

1. Validity of the quotation should be at least 90 days from the date of submission.
 2. The Delivery schedule shouldn't exceed 5 weeks from the date of placement of order.
 3. The quotations for the equipment in foreign exchange, if it is to be imported. The cost should be based on FOB, Factory. If equipment is indigenous, the quote should be in INR.
 4. Taxes, terms and conditions should be clearly mentioned.
 5. Institute makes payment after delivery and successful installation. The payment is by RTGS for which NEFT forms need to be duly filled and complied. In case the payment terms are different, it should be mentioned clearly. If equipment is to be imported, the address of the company in whose name the LC is to be opened should be stated.
 6. Payment terms and conditions should be clearly mentioned. No advance payment is given by IIT Delhi for capital equipment.
