Technical Specifications for Nano Drop Spectrometer

- 1) Instrument: Table top UV/V is Spectrophotometer capable of measuring micro liter volumes of Nucleic Acids (DNA, RNA) and proteins.
- 2) Minimum volume with which measurement of absorbance can be done should be 1 μ l.
- 3) System should not require any adaptors or another accessory for operation.
