### INSTRUCTIONS FOR ONLINE BID SUBMISSION

As per the directives of Department of Expenditure, this quotation / tender document has been published on the Central Public Procurement Portal (URL: <u>http://eprocure.gov.in/eprocure/app</u>). The bidders are required to submit softcopies of their bids electronically on the CPP portal, using valid Digital Signature Certificates (DSC). The instructions given below are meant to assist the bidders in registering on the CPP portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP portal.

### REGISTRATION

- Bidders are required to enrol on the e-procurement module of the Central Public Procurement portal (URL: <u>http://eprocure.gov.in/eprocure/app</u>) by clicking on the link, "click here to enrol". Enrolment on the CPP portal is free of charge.
- 2. As part of the enrolment process, the bidders will be required to choose a unique user name and assign a password for their accounts.

- 1. The Principal/Owner commits itself to take all measures necessary to prevent corruption and to observe the following principles:

- It is required that each Bidder/Contractor (including their respective officers, employees and agents) adhere to the highest ethical standards, and report to the Government / Department all suspected acts of fraud or corruption or coercion or collusion of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.
- 2. The Bidder(s)/Contractor(s) commits himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:

Similarly Bidder(s) / Contractor(s) of Indian Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participate in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent/parallel tender for the same item.

### **COMMERCIAL AND ADDITIONAL CONDITIONS**

### **1.GENERAL**

1.1. This specification covers supply and delivery of materials at site, all preparatory work assembly and installation, commissioning putting into service at site.

### **1.2.** Location: Udaigiri & Girnar Hostel at IIT Delhi.

- **1.3.** The work shall be executed as per CPWD General Specifications for Electrical Works Part-I (Int.) 2013, Part-II (Ext.) 1994, Fire as amended upto date, relevant I.E. Rules, BIS/IEC and as per directions of Engineer-in- Charge. These additional specifications/conditions are to be read in conjunction with above and in case of variations; specifications given in these additional conditions shall apply. However, nothing extra shall be paid on account of these additional specification and conditions, as the same are to be read along with schedule of quantities for the work.
- **1.4.** The tenderer should in his own interest visit the site and get familiarize with the site conditions before tendering.
- **1.5.** No T&P shall be issued by the Department and nothing extra shall be paid on account of this.

### **2.COMMERCIAL CONDITIONS:**

**2.1. Type of contract:** The work to be awarded by this tender shall be treated as indivisible works contract.

### 2.2. Submission and opening of Tenders:
