**Applications in person for issue of tenders shall accompany the following: -**



- ii. Earnest money amounting to ₹ 7,251/- in the form of Deposit at Call receipt of Scheduled Bank Guaranteed by the Reserve Bank of India or Banker's Cheque or Demand Draft drawn in favour of I.I.T. Delhi.
- iii. Attested valid TIN Registration Certificate under D-VAT (including deposit receipt etc.)
- iv. Completion Certificates issued by an officer not below the rank of Executive Engineer of similar works completed by the Agency. The attested copies of completion certificate shall only be accepted.
- v. Registration of firms / Contractors must be valid on the last day of issue of Tenders. (if applicable)
