Interested parties are required to submit the TECHNICAL and FINANCIAL bids in separate sealed envelopes; these should be marked clearly as “Technical Bid” and “Financial Bid”, respectively. Both the sealed envelopes should be sent in a single sealed envelope clearly marked as “Quotation for DLSR Camera and telephoto lens”. The Quotations should be addressed to: Prof. Anjan Ray and submitted in the Department of Mechanical Engineering, IIT Delhi, Hauz Khas, New Delhi 110016 latest by 5:00 PM on 13th October.

The following aspects should also be taken care of

1. Separate sealed technical and sealed financial bids should be given in a single sealed envelope
2. Compliance table indicating adherence to each item of the technical specification.
3. The camera body and Lens should be from the same OEM.
4. Validity of the quote should be at least 90 days
5. A warranty of at least 1 year from date of installation should be given. Rates for an extended warranty/AMC up to 3 years may be given
6. A company profile should be included in the technical bid
7. The profile should include the following at minimum:
 - a. The parent company base in India, its customer list and the number of pieces of DSLR camera sold by it in India.
 - b. The Indian agent's profile highlighting its past experience and number of pieces of similar camera sold by it in India.
8. In the case the bid is given through an agent, a valid agent-ship certificate should be attached
9. Each bidder must submit the NEFT mandate form for registering as a vendor at IIT Delhi.

10. If the item is a proprietary item, a proprietary certificate from the principal manufacturer should be included
11. Indian agent should also include a copy of letter enlisting with Department of Expenditure, Ministry of Finance as per GOI requirements
12. Accessories needed for functioning of the camera should be included in the quote and clearly specified. Optional, additional, accessories available may also be quoted separately.
13. Imported items should be quoted on FOB basis (Freight on Board) and FOB price be provided.
14. A signed hand filled compliance sheet as attached, stating whether each of the specifications asked for are being met or not, should be included in the technical bid
15. If some specifications are being met, deviations may be clearly stated. In the unlikely event that none of the vendors are able to meet all the specifications, the committee reserves the right to waive or relax any of the requirements at the technical evaluation stage.
16. No advance payment shall be made.
17. Payment will be made through wire transfer after successful installation.
18. The quotation received after due date will not be considered.
19. The institute reserves the right to reject a quotation without assigning any reasons.

After opening the technical bids, a demonstration of the product may be sought in IIT. The committee will shortlist the bids based on an evaluation of the technical bid, the demo, the efficiency (ease of use), ability to maintain and other aspects of the requirements. Financial bid would be opened only for shortlisted companies.
