Sealed quotations in two-bid (*Technical and Commercial in separate sealed envelopes*) are invited for the purchase of a **“Charge amplifier for existing accelerometers B&K 4370, 4368, 4366 and 8307”** as per the details given below, by **2nd December 2014** (before 4 p.m.) to ITMMEC Office (Room No. V244). Your quotation should be superscribed **“Technical/Commercial Quotation for Charge amplifier for existing accelerometer B&K 4370, 4368, 4366 and 8307”**.

**SPECIFICATIONS**

The instrument should have:

- Battery and AC power operation suitable for field and laboratory measurements of vibration.
- Charge input with possibility of different transducer sensitivity settings. Sensitivity up to 10 V/pC.
- Low and high frequency limit settings.
- Built in integrator and double integrator for velocity and displacement outputs.
- Test oscillator.

***Other Terms & Conditions:***

1. **Validity of the quotation required:** 90 days
2. **Warranty:** 01 year (*also quote separately for extended warranty for additional 2 years*)
3. Installation, commissioning and staff training expenses are to be borne by the supplier.
4. **Please quote the price of the above item on FOB basis.**
5. The bidder must be a reputed OEM or an authorized local agent.
6. If there is any Indian agent associated with the foreign supplier, then an appropriate **“Letter of Authorization”** certificate from the foreign supplier has to be provided with the quotation.
7. Further, if the Indian agent quotes for the above mentioned item on behalf of the foreign supplier, then the Indian agent should be enlisted with the Department of Expenditure, Ministry of Finance (Government of India). Copy of the supporting documents has to be enclosed with the quotation. Further, in the letter it must be clearly stated from the principles that the bidder is an authorized agent.
