
1. Separate Technical and commercial bids are required to be submitted in separate sealed envelopes.

Envelop A: Technical Bid

1. Compliance chart should be clearly attached along with technical bid.
(Note: The Compliance chart must match with the Technical Datasheet)
2. The model no. must be mentioned with the technical datasheet.
3. If the quote is submitted by the representative of Principals/Manufacturers, a Valid Agency ship/Dealership Certificate should be enclosed **specific to this tender** at a recent date in original.
4. The Bidder should be ISO Certified (Copy of ISO Certificate should be enclosed).

Envelop B: Financial Bid

1. Validity of the quotation should be at least 90 days from the date of submission.
 2. The Delivery schedule shouldn't exceed 5 weeks from the date of placement of order.
 3. The Quote should be in INR.
 4. Taxes, terms and conditions should be clearly mentioned.
