Technical Specifications

Precision rotation stage made of quality material to avoid corrosion/rust, Optics of research quality and well designed mechanics for maintenance free usage over many years.

Scale dia.: 175-190 mm made of corrosion/rust free quality scale material

Double ended vernier, **least count: 20 seconds**

In built lighting arrangement on main/vernier scale

Objective: achromatic, Focal Length: 175-230 mm, aperture 30-32 mm

Reticule: 90 degrees cross

Precision grade micrometer controlled slit with collimator on a tilt adjustable holder

Coarse and fine motion for telescope and collimator

Prism table with leveling screws, prism holder and associated accessories

Terms and conditions

- The technical bid and the financial bid should be put in separate covers and sealed. Both the sealed covers should be put into a bigger cover, superscripting Tender Number.
- The Bidder should be the Original Equipment Manufacturer/authorized dealer. Letter of authorization from the Original Equipment Manufacturer specific to this tender should be enclosed in the case of an authorized dealer. An undertaking from the OEM is required stating

that they would facilitate the bidder on a regular basis for product support and for the warranty as well.

- The quotations shall be valid for 120 days from the due date.
- Non compliance of tender terms, non submission of required documents, lack of clarity of the specifications, contradiction between bidder specifications and supporting documents etc. will lead to rejection of the bid.
- Prices to be quoted F.O.R. IIT Delhi and delivery shall be made at the Institute's premises.
- Prices quoted must include packing and delivery charges. Percentages of taxes shall also be clearly indicated. In case of import supply, the price should be quoted on FOB basis only.
- The supplier shall clearly mention the warranty and delivery schedule of the item.
- Payment: Payment will be made through irrevocable Letter of Credit in case of foreign Supplier. For Indigenous supplies, 100% payment shall be made against delivery, inspection and acceptance of the equipment at IITD in good condition.
