Indian Institute of Technology Delhi invites sealed quotations from reputed Manufacturers/Authorized distributors/Agencies/Companies for “**Supply of Miniature Pore Pressure Transducers**”. Details of the technical specification, estimated quantity, terms and conditions are given below:

**Technical Specifications**

- Quantity- 3.
- Type- Miniature Type.
- Range- 200kPa capacity.
- Measurement -Strain based transducer.
- Size-External diameter of the diaphragm should be less than 15 mm.
- Height- 5-10 mm.
- Weight - Should be less than 5 gm.
- Should include input/output cable.
- Cable should be connected to the side of the cell.

**Terms and Conditions**

The terms and conditions for submission of quotations are given below:

1. The item being quoted should be of original manufacturer and non-standard item should not be quoted. All details specification and model no of the item should be clearly mentioned and attached with the quotation. In case of proprietary item, necessary certificate in support of the same should be attached from original manufacturer.
2. The quotation should clearly mention the following:
  - Quantity, basic price.
  - CST / Sales Tax / VAT/Packing and forwarding charges, if any.
  - Freight and insurance charge.
  - Octroi surcharge.
  - Charges for additional warranty beyond the free warranty period, if any, to be quoted separately.
  - Educational discount.
3. Dealership certificate (in case of dealers) should be enclosed.
4. List of reputed organizations/Institutions, where similar orders have been executed during last three years should be provided.
5. The leaflet/ catalogue, etc. of the technical features of the offered item must be submitted for proper evaluation.

6. Delivery period for item at IIT Delhi should not exceed 45 days from the date of issue of purchase order.
7. Nature and maximum period of free warranty period offered for the item is to be clearly specified.
8. The rate to be quoted by the agency should be valid for a period of three months from the date of placement of orders.
9. The quotations are liable to be rejected if the foregoing conditions are not complied with. The quotation should be complete in all respects and duly signed wherever required. Incomplete and unsigned offer will not be accepted.
10. Payment will be made only after receipt of the item in good and working condition as per specifications and after satisfactory installation.
11. The last date for receipt of price offer is -14.09.2015.
12. The Technical Bid with detail specification and Financial Bid should be in two separate sealed envelopes, put into one larger envelope. The envelope should bear the title of the item quoted and the content.
