In case of failure by the contractor to supply the Performance Guarantee within the specified period full Earnest Money will be forfeited and the tender shall be treated void. The Performance Guarantee shall be initially valid up to the stipulated date of completion plus 60 (Sixty) days beyond that.

(2) Applications in person for issue of tenders shall accompany the following (except E.M.D. which shall be submitted along with submission of tender)

Firms/ Contractors must have completed satisfactorily one similar work amounting to not less than ₹ 17.10 Lacs or two similar works each amounting to not less than ₹ 10.70 Lacs or three similar works each amounting to not less than ₹ 8.55 Lacs during last 07 financial years ending March 2012 for the subject work
2. Cost of tender ₹ 500/- (₹ Five Hundred Only) in cash deposit in S.B.I. or Canara Bank at IIT Delhi.(Non- refundable)
3. Earnest money amounting to ₹ 42,695/- (₹ Forty Two Thousand Six Hundred Ninety Five Only) in the form of Banker's Cheque or Demand Draft drawn in favour of IIT Delhi.
4. Attested valid TIN Registration Certificate under D-VAT (including preferably deposit receipt etc.)
5. Attested Copies of Registration of firms/ Contractors must be valid on the last day of issue of tenders or extended date of issue of tender.
6. Completion Certificates issue by an officer not below the rank of Executive Engineer of similar works completed by the agency.
