The Performance Guarantee shall be initially valid up to the stipulated date of completion plus 60 (Sixty) days beyond that.

(2) **Applications in person for issue of tenders shall accompany the following: -**



2. Earnest money amounting to ₹ 8,136/- (₹ Eight Thousand One Hundred Thirty Six Only) in the form of **Banker's Cheque or Demand Draft drawn in favour of I.I.T. Delhi.**
3. Attested valid TIN Registration Certificate under D-VAT (including deposit receipt etc.)
4. Completion Certificates issued by an officer not below the rank of Executive Engineer of similar works completed by the Agency.
5. Registration of Firms/ Contractors must be valid on the last day of issue of Tenders. (if applicable)
6. Work means only work under Government/ Public Sector Under taking/ Autonomous bodies.
