In case of failure by the contractor to supply the Performance Guarantee within the specified period full Earnest Money will be forfeited and the tender shall be treated void. The Performance Guarantee shall be initially valid up to the stipulated date of completion plus 60 (Sixty) days beyond that

(2) **Applications in person for issue of tenders shall accompany the following: -**

1. **Eligibility Criteria:** - Tenders should have satisfactorily completed similar works of magnitude as specified below:
 - (a) Three similar works each of value not less than ₹ 2.10 Lacs Two similar works each of value not less than ₹ 3.15 Lacs or One similar work of value not less than ₹ 4.20 Lacs in last 07 years ending 31/03/2012.
 - (b) The Value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 07% per annum, calculated from the date of completion to last date of receipt of applications for Tender.



Cost of tender ₹ 500/- (₹ Five Hundred Only) in cash deposit in S.B.I. or Canara Bank at IIT Delhi. (Non - refundable).


3. Earnest money amounting to ₹ 10,491/- (₹ Ten Thousand Four Hundred Ninety One Only) in the form of **Banker's Cheque or Demand Draft drawn in favour of I.I.T. Delhi.**
4. Attested valid TIN Registration Certificate under D-VAT
5. Completion Certificates issued by an officer not below the rank of Executive Engineer of similar works completed by the Agency.
6. Attested copy of Registration Certificates to be submitted. Registration of Firms/ Contractor must be valid on the last day of issue of tenders or extended date of issue of tenders.
7. Works means only work under Government/ Public Sector Undertaking/ Autonomous bodies.
8. Similar works means works pertaining to works of Maintenance of Buildings/ Renovation/ Addition/Alteration/ Rehabilitation/ New Construction of buildings (Civil works).
