Firms must have executed three similar works each of value not less than 40% of estimated cost or two similar work each of value not less than 60% of estimated cost or one similar works of value not less than 80% of estimated cost in last 7 years in Govt./Semi Govt./Autonomous body organizations. Similar work means repair and maintenance of Electrical Installations.

Tender documents will not be issued without the documentary proof as required.

The performance guarantee shall be initially valid upto the stipulated date of completion plus 60 (Sixty days) beyond that.

6. Electrical License issued from competent authority.

Tenders shall be submitted in the prescribed manner in Sealed Cover.


