Firms must have executed three similar works each of value not less than 40% of estimated cost or two similar work each of value not less than 60% of estimated cost or one similar works of value not less than 80% of estimated cost in last 7 years in Govt./Semi Govt./Autonomous body organizations. Similar work means operations and routine maintenance/repair of Central AC Plants.

Tender documents will not be issued without the documentary proof as required.

In case of failure by the contractor/firm to submit the performance guarantee within the specified period, full Earnest Money will be forfeited & the tender shall be treated as void. The performance guarantee shall be initially valid upto the stipulated date of completion plus 60 (Sixty days) beyond that.

5. Successful tenderer shall submit the list of staff with relevant attested copies of certificates within 15 days of issue of letter of intent.


Tenders shall be submitted in the prescribed manner in Sealed Cover.
