Firms must have executed three similar works each of value not less than 40% of estimated cost or two similar work each of value not less than 60% of estimated cost or one similar works of value not less than 80% of estimated cost in last 7 years in Govt./Semi Govt./Autonomous body organizations. Similar work means Maintenance and refilling of fire extinguishers. Tender documents will not be issued without the documentary proof as required.
