Similar work means operations and routine maintenance / repair of Central AC Plants and D.G. set. Tender documents will not be issued without the documentary proof as required.

The performance guarantee shall be initially valid upto the stipulated date of completion plus 60 (Sixty days) beyond that.

Tenders shall be submitted in the prescribed manner in Sealed Cover.


