In case of failure by the Contractor to supply the performance guarantee within the specified period, full earnest money will be forfeited and the tender shall be treated as void. The performance guarantee shall be initially valid up to the stipulated date of completion plus 60 (Sixty) days beyond that.
- 2. Applications in person for issue of tenders should accompany the following: -
 - Firms/ Contractors must have completed satisfactorily one similar work amounting to Rs 4.75 i) Lacs or two similar works each amounting to Rs. 2.95 Lacs or three similar works each amounting to Rs. 2.40 Lacs during last 7 financial years for the subject work.
 - Cost of tender Rs 500.00 (Rs. Five Hundred only) in cash deposit in S.B.I. or Canara Bank at ii) I.I.T. Delhi. (Non-refundable).
 - Earnest money amounting to Rs. 11,760/- in the form of Deposit at call receipt of scheduled iii) Bank guaranteed by the Reserve Bank of India or Banker's Cheque or Demand Draft drawn in favour of I.I.T. Delhi.
 - Attested valid TIN Registration Certificate under D-VAT iv)
