General description: Tabletop DC Plasma Sputtering System for the deposition of thin films of metals such as Au, Al and Cu.

THE DETAIL TECHNICAL SPECIFICATIONS OF THE SYSTEM ARE AS FOLLOWS:

1.	Input Power	220 - 240V, 50 Hz, ≤ 2000W
2.	Specimen chamber	Fuséd glass chamber.
3.	Substrate holder	The substrate holder should be able to hold the samples up to 50 mm in diameter.
4.	Targets	Targets that are required within the standard package are Au, Cu and Al with diameter of 40 mm or higher. The targets should be minimum of 4N purity. The system should be able to deposit three types of metal films on the substrate sequentially without breaking the vacuum in the chamber.
5.	Gas atmosphere	One needle valve alongwith a flowmeter should be installed to allow Ar gas flow inside the chamber to achieve plasma coating.
6.	Accessories included	The following accessories should be included with the system: i) Vane rotary vacuum pump 200L/min or higher (external) with Pirani gauge. ii) Vapour trap to prevent back streaming of oil into the vacuum chamber. iii) Stainless steel bellows with KFD-25 adapter and clamps
7.	Overall dimension	The overall dimension of the plasma sputtering system (excluding rotary pump) should be less than 500mm × 400mm × 500mm (L×W×H).
9.	Warranty	Minimum one year warranty should be provided.
