The performance guarantee shall be initially valid up to the stipulated date of completion plus 60 (Sixty) days beyond that.

 - Cost of tender Rs. 500.00 (Rs. Five Hundred) in cash deposit in S.B.I. or Canara Bank at I.I.T. Delhi. (Non-refundable).
 - iii) Tenders shall be accompanied with Earnest money of Rs. 25,976,00 in the form of Banker's cheque or Demand draft or fixed deposit receipt of a schedule bank drawn in favour of LLT. Delhi.
