- 4. Cost of quotation Rs. 500.00 [Counterfoil of challan] to be deposited in SBI or Canara Bank at IIT Delhi [non-refundable]

Earnest Money should be deposited alongwith the quotation documents in separate envelope marked as "Earnest Money". Both sealed envelopes [EMD and Quotation Document] marked as Earnest Money and Quotation shall be submitted together in another sealed envelope superscripted with name of work and due date of opening. The envelope marked quotation shall be opened whose Earnest Money placed in the other envelope marked as Earnest Money is found to be in order.
