Indian Institute of Technology Delhi invites offline Bids (Technical bid and Commercial bid) from eligible and experienced OEM (Original Equipment Manufacturer) OR OEM Authorized Dealer for **supply, installation & integration of Hood and Duct arrangement** with (warranty period as stated at page #1 of this tender) on site comprehensive warranty from the date of receipt of the material as per terms & conditions specified in the tender document, which is available on CPP Portal <http://eprocure.gov.in/epublish/app> .

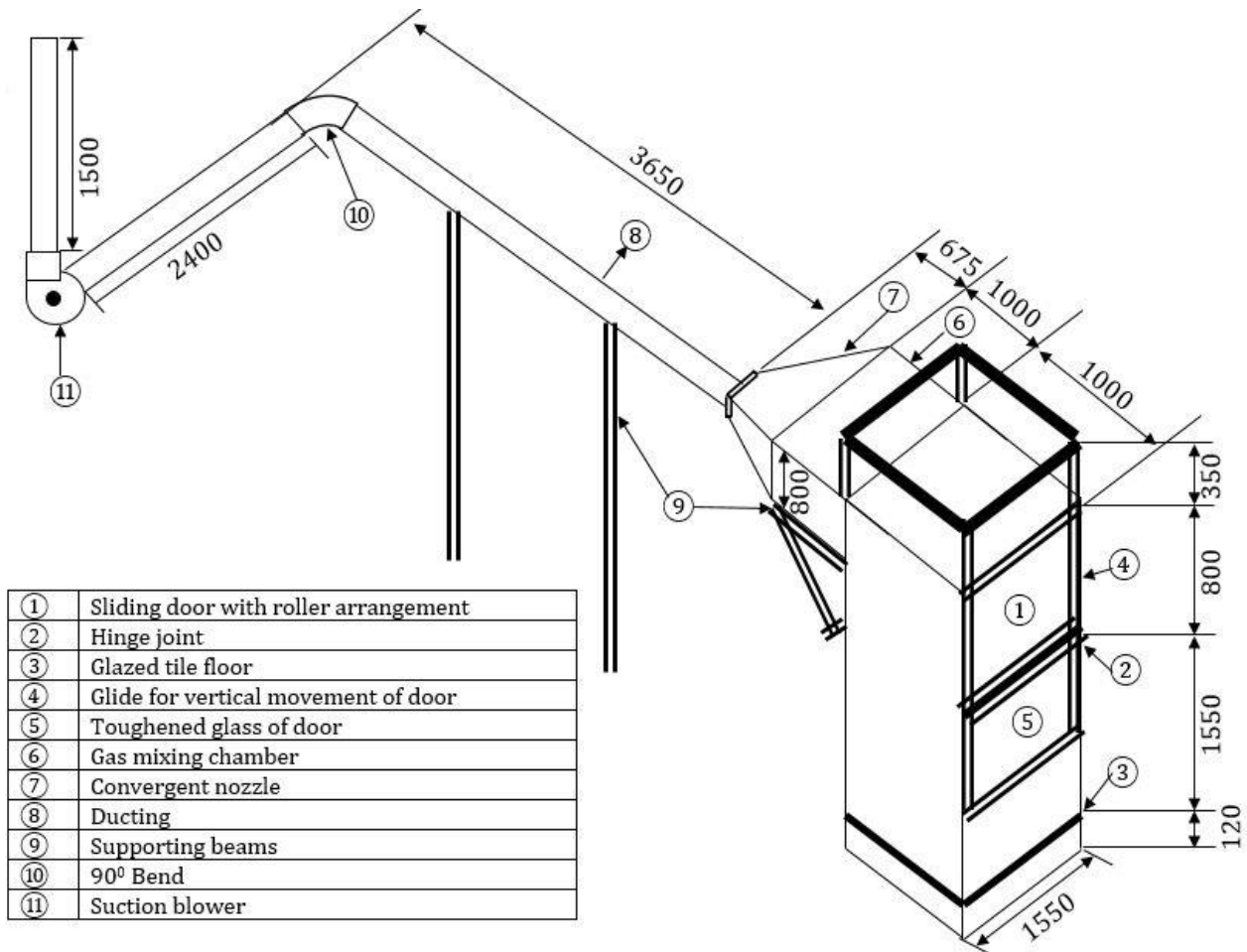
Technical and Manufacturing Specifications of Hood and Duct

A hood and duct arrangement needs to be fabricated to capture emissions from biomass combustion devices. Hood should be closed from all the sides except front which carries sliding shutter made up of a transparent toughened glass of 6 mm thickness. The shutter of the hood is divided into two parts: top and bottom. Bottom of the shutter should be foldable by providing hinge joint between top and a bottom portion. The top portion of the shutter should be provided with roller arrangement in order to facilitate movement in a vertical direction. The clear openable height of shutter should be at least 2000 mm to allow the operator to access the hood easily. The hood must be connected with a duct through the gas mixing chamber and reducer having flanges at the joints with proper sealings. Appropriate supporting beams should be used wherever required to support the gas mixing chamber and the duct. There should be a suction blower at the end of the duct to pull air through the fume hood and release diluted exhaust gas into the atmosphere. The speed of the suction blower should be variable according to the capacity of the combustion device being tested. Hence, the speed of the blower must be controlled with the help of variable frequency drive (VFD).

TECHNICAL SPECIFICATION:

Sl. No.	Technical Specifications
1.	Dimensions of Hood: 1550 mm × 1000 mm × 2820 mm (L × W × H)
2.	The material used for hood should be Galvanized Iron and thickness should be at least 14 gauge.

3.	The floor of Glazed tiles inside the hood of height 120 mm.
4.	Sliding shutter made up of 6 mm thick toughened glass should be in two portions with the provision of hinged joint.
5.	The clear openable height of shutter – 2000 mm (Approx.)
6.	2 x 20 watt LED bulbs fitted in the work chamber.
7.	Electrical built-in extension board with 5 Nos. Switch / Sockets, 16 Amps MCB and mains cord & plug.
8.	Dimensions of Gas Mixing chamber: Cross-section - 1550 mm × 800 mm and Length: 800 mm.
9.	Convergent nozzle with suitable flanges having proper sealing to connect gas mixing chamber with the duct.
10.	Exhaust ducting of square cross-section having a side of 200 mm, GI material with necessary flanges/cones & bends etc.
11.	The total length of ducting would be around 7500 mm.
12.	Suction Blower - Suitable capacity/rating Centrifugal type for 1000 cfm at 50 mm static pressure flow – with GI impeller and housing and with speed regulator.
13.	Variable frequency drive to vary exhaust flow rate in the duct according to requirement.

Important Note:

- Bidder should have its own manufacturing facility for this kind of fume hood along with duct which can be visited by members of the purchase committee.
- Bidders should provide at least two purchase orders/invoice for proof of the past selling of similar setup to IITs/ R&D organizations.
- Bidder is responsible for the installation of the complete arrangement.
- At least one-year warranty of complete unit should be provided.
- Three-year warranty will be preferable.
- Also mention the additional cost of the warranty, if any.

Terms & Conditions Details

Sl. No.	Specification
1.	Due date: The tender has to be submitted off-line before the due date. The offers received after the due date and time will not be considered.
2.	Preparation of Bids: The offer/bid should be submitted in two bid systems (i.e.) Technical bid and financial bid. The technical bid should consist of all technical details along with commercial terms and conditions. Financial bid should indicate item wise price for the items mentioned in the technical bid.
3.	EMD (if applicable): The tenderer should submit an EMD amount through RTGS/NEFT. The Technical Bid without EMD would be considered as UNRESPONSIVE and will not be accepted. The EMD will be refunded without any interest to the unsuccessful bidders after the award of contract. Refer to Schedule (at page 1 of this document) for its actual place of submission.
4.	Refund of EMD: The EMD will be returned to unsuccessful Tenderer only after the Tenders are finalized. In case of successful Tenderer, it will be retained till the successful and complete installation of the equipment.
5.	Opening of the tender: The offline bid will be opened by a committee duly constituted for this purpose. Offline bids (complete in all respect) received along with UTR info of EMD fund transfer (if any) will be opened as mentioned at “Annexure: Schedule” in presence of bidders representative if available. Only one representative will be allowed to participate in the tender opening. Bid received without EMD (if present) will be rejected straight way. The technical bid will be opened offline first and it will be examined by a technical committee (as per specification and requirement). The financial offer/bid will be opened only for the offer/bid which technically meets all requirements as per the specification, and will be opened in the presence of the vendor’s representatives subsequently for further evaluation. The bidders if interested may participate on the tender opening Date and Time. The bidder should produce authorization letter from their company to participate in the tender opening.
6.	Acceptance/ Rejection of bids: The Committee reserves the right to reject any or all offers without assigning any reason.
7.	Pre-qualification criteria: (i) Bidders should be the manufacturer / authorized dealer. Letter of Authorization from original equipment manufacturer (OEM) on the same and specific to the tender should be enclosed. (ii) An undertaking from the OEM is required stating that they would facilitate the bidder on a regular basis with technology/product updates and extend support for the warranty as well. (Ref. Annexure-II) (iii) OEM should be Nationally/Internationally reputed Company. (iv) Non-compliance of tender terms, non-submission of required documents, lack of clarity of the specifications, contradiction between bidder specification and supporting documents etc. may lead to rejection of the bid. (v) In the tender, either the Indian agent on behalf of the Principal/OEM or Principal/OEM itself can bid but both cannot bid simultaneously for the same item/product in the same tender. 9.	Force Majeure: The Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it’s delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

	<ul style="list-style-type: none"> For purposes of this Clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Such events may include, but are not limited to, acts of the Purchaser either in its sovereign or contractual capacity, wars or revolutions, fires, floods, epidemics, quarantine restrictions and freight embargoes. 12.	Delivery and Documents: Delivery of the goods should be made within a maximum of 08 to 16 weeks from the date of placement of purchase order.
