In case of failure by the Contractor to supply the performance guarantee within the specified period, full earnest money will be forfeited and the tender shall be treated as void. The performance guarantee shall be initially valid up to the stipulated date of completion plus 60 (Sixty) days beyond that.

 - I) Cost of tender Rs. 500/- (Rs. Five Hundred Only) in cash deposit in S.B.I. or Canara Bank at IIT Delhi. (Non-refundable)
 - II) Earnest money amounting to Rs. 4,800/- in the form of Banker's Cheque or Demand Draft drawn in favour of IIT Delhi.
 - III) Attested valid TIN Registration Certificate under D-Vat. (Including deposit receipt etc.)
 - IV) Completion certificated issued by an officer not below the rank of Executive Engineer of similar works completed by the Agency.
 - V) Registration of firms/ Contractors must be valid on the last day of issue of Tenders. (If applicable)
 - VI) Work means only work under Government/Public Sector Under taking/Autonomous bodies.
 - VII) Similar works means Sanitation work Fogging operation/Insecticidal Spraying.
 - VIII) Tenders shall be submitted in the prescribed manner in Sealed Cover.
 - IX) Telegraphic, Postal & Conditional tenders are liable to be summarily rejected.
