Indian Institute of Technology Delhi invites offline Bids (Technical bid and Commercial bid) from eligible and experienced OEM (Original Equipment Manufacturer) OR OEM Authorized Dealer for **<supply, installation & integration of Fabrication of superstructure >** with (warranty period as stated at page #1 of this tender) on site comprehensive warranty from the date of receipt of the material as per terms & conditions specified in the tender document, which is available on CPP Portal <http://eprocure.gov.in/epublish/app> .

**TECHNICAL SPECIFICATION:**

<b>Sl. No.</b>	<b>Technical Specifications</b>
	<p><b>Jointing detail (refer Figure 2)</b> The beam and the column shall be attached together with the help of steel ribbed bars (grade Fe 500 HYD) of 12 mm diameter, embedded into all the individual bamboo culms of beams and columns. The internal diameter of each bamboo shall be first enhanced and grooved by a threading like mechanism. The steel bars shall then be embedded into all the bamboo culms of the beam and grouted with standard Araldite epoxy. 350 mm of 12 <math>\phi</math> rebars shall be embedded into the bamboo culms so that premature pull out of bars could be ruled out. The entire joint shall then filled with epoxy as adhesive, to form a composite joint, as shown in detail in Figure 3. The aggregate-epoxy mixture shall be poured into the wooden mould and levelled in order to complete the unification of beam and column so as to achieve a rigid joint.</p> <p><b>Preparation of Epoxycrete</b> The coarse aggregate was selected in range of 5 mm to 12 mm, and fine aggregate was chosen in the form of rounded river shingle in the size range of 3 mm to 8 mm, mixed with fine to large sand in the range of 2 to 3 mm. Polypropylene fibres (6 mm, 12 mm, 18 mm in equal proportion) were added also as a reinforcing agent. By trial and error, coarse aggregate: river shingles: sand was proportioned in ratio 1:0.8:1.3. For each set, 60 to 70 grams of fibres (fine white, small, medium and large along with strong black fibre) were added. This thesis proposes bamboo joints using this epoxycrete.</p>

1.	<b>Due date:</b> The tender has to be submitted off-line before the due date. The offers received after the due date and time will not be considered.
2.	<b>Preparation of Bids:</b> The offer/bid should be submitted in two bid systems (i.e.) Technical bid and financial bid. The technical bid should consist of all technical details along with commercial terms and conditions. Financial bid should indicate item wise price for the items mentioned in the technical bid.
3.	<b>EMD (if applicable):</b> The tenderer should submit an EMD amount through RTGS/NEFT. The Technical Bid without EMD would be considered as UNRESPONSIVE and will not be accepted. The EMD will be refunded without any interest to the unsuccessful bidders after the award of contract. Refer to Schedule (at page 1 of this document) for its actual place of submission.
4.	<b>Refund of EMD:</b> The EMD will be returned to unsuccessful Tenderer only after the Tenders are finalized. In case of successful Tenderer, it will be retained till the successful and complete installation of the equipment.
5.	<b>Opening of the tender:</b> The offline bid will be opened by a committee duly constituted for this purpose. Offline bids (complete in all respect) received along with UTR info of EMD fund transfer (if any) will be opened as mentioned at “Annexure: Schedule” in presence of bidders representative if available. Only one representative will be allowed to participate in the tender opening. Bid received without EMD (if present) will be rejected straight way. The technical bid will be opened offline first and it will be examined by a technical committee (as per specification and requirement). The financial offer/bid will be opened only for the offer/bid which technically meets all requirements as per the specification, and will be opened in the presence of the vendor’s representatives subsequently for further evaluation. The bidders if interested may participate on the tender opening Date and Time. The bidder should produce authorization letter from their company to participate in the tender opening.
6.	<b>Acceptance/ Rejection of bids:</b> The Committee reserves the right to reject any or all offers without assigning any reason.
7.	<b>Pre-qualification criteria:</b> (i) Bidders should be the manufacturer / authorized dealer. Letter of Authorization from original equipment manufacturer (OEM) on the same and specific to the tender should be enclosed. (ii) An undertaking from the OEM is required stating that they would facilitate the bidder on a regular basis with technology/product updates and extend support for the warranty as well. (Ref. Annexure-II) (iii) OEM should be Nationally/Internationally reputed Company. (iv) Non-compliance of tender terms, non-submission of required documents, lack of clarity of the specifications, contradiction between bidder specification and supporting documents etc. may lead to rejection of the bid. (v) In the tender, either the Indian agent on behalf of the Principal/OEM or Principal/OEM itself can bid but both cannot bid simultaneously for the same item/product in the same tender. 8.	<b>Performance Security:</b> The supplier shall require to submit the performance security in the form of irrevocable bank guarantee issued by any Indian Nationalized Bank for an amount which is stated at page #1 of the tender document within 21 days from the date of receipt of the purchase order/LC and should be kept valid for a period of 60 days beyond the date of completion of warranty period.
9.	<b>Force Majeure:</b> The Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it’s delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure.

	<ul style="list-style-type: none"> <li>For purposes of this Clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. 	<p><b>Jointing detail (refer Figure 2)</b> The beam and the column shall be attached together with the help of steel ribbed bars (grade Fe 500 HYD) of 12 mm diameter, embedded into all the individual bamboo culms of beams and columns. The internal diameter of each bamboo shall be first enhanced and grooved by a threading like mechanism. The steel bars shall then be embedded into all the bamboo culms of the beam and grouted with standard Araldite epoxy. 350 mm of 12 <math>\phi</math> rebars shall be embedded into the bamboo culms so that premature pull out of bars could be ruled out. The entire joint shall then filled with epoxy as adhesive, to form a composite joint, as shown in detail in Figure 3. For each set, 60 to 70 grams of fibres (fine white, small, medium and large along with strong black fibre) were added. This thesis proposes bamboo joints using this epoxycrete.</p>
