3. Attested copy of work completion certificate as per following
  - a. Should have satisfactorily completed the works as mentioned below during the last Seven years ending **previous day of last date of submission of bids**.
    - i. **Three** similar works each costing not less than **Rs.41,227.00**, or **two** similar works each costing not less than **Rs.61,841.00**, or one similar work costing not less than **Rs.82,454.00**.
    - ii. The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of submission of financial bid.
  - b. Completion certificates are required to be got issued by an officer not below the rank of Executive Engineer of similar works completed by the Firm. The work experience certificates submitted by the bidders shall clearly indicate (a) the completed cost of the work and (b) actual date of completion of the work.
  - c. **Similar work means SITC of Electrical Timer Panel or Electrical Distribution Panel**
  - d. **Work means** work done with some Central Government Department / State Government Department / Central Autonomous Body / State Autonomous Body / Central Public Sector Undertaking / State Public Sector Undertaking / City Development Authority / Municipal Corporation of City formed under any Act by Central / State Government and published in Central / State Gazette.

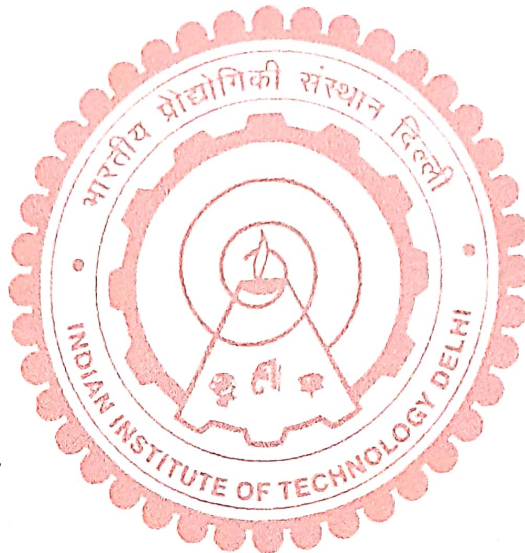
