Instructions for Online Bid Submission:

As per the directives of Department of Expenditure, this tender document has been published on the Central Public Procurement Portal (<u>URL:http://eprocure.gov.in/eprocure/app)</u>. The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL: http://eprocure.gov.in/eprocure/app) by clicking on the link "Click here to Enroll". Enrolment on the CPP Portal is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / eToken.

SEARCHING FOR TENDER DOCUMENTS

2. THREE ZONE FURNACE HEATING SYSTEM: Quantity: 1

- a) Tube dimensions: 55mm ID x 60mm OD x 1200mm Long, Dimensional tolerance: ±2mm in diameter, ±25mm in length (or better),
- b) The system design must not place any load on the quartz/ceramic tube, and be of the split-top type so that the tube can be removed by opening the furnace, and raising the tube manually.
- c) Max (any zone) process temperature: 1200 °C, (or better) with specifications for the changeover temperature between quartz and ceramic.
- d) Tube: Quartz, (included)
- e) Heating elements: consistent with the specified ramp rate,

The temperature in the transition region (whose width must be minimised) must never lie beyond the range represented by the two neighbouring temperature set points. - g) Thermocouple: Pt thermocouples with RCA Sheathing. Each heating zone must have an independent thermocouple. Thermocouple outputs must be available to temperature controller for controlling the zone temperature.
- h) Thermal insulation: With ceramic fibre boards/blankets, Casing: Double walled air jacketed, SS 410 outer casing with ventilation,
- Temperature control: Programmable IEEE 488.2 (SCPI) / LabVIEW controllable PID controller for each zone having minimum 16 segments, complete with slave controllers. Flanges must contain SS feedthroughs (KF25) for vacuum and one gas line. The gas line must be downstream of a mixer preceded by individual MFCs. The vendor may suggest alternate possibilities in design and in all cases, demonstrate optimal operation.
