Instructions for Online Bid Submission:

As per the directives of Department of Expenditure, this tender document has been published on the Central Public Procurement Portal ([URL:https://eprocure.gov.in/eprocure/app](https://eprocure.gov.in/eprocure/app)). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal ([URL:https://eprocure.gov.in/eprocure/app](https://eprocure.gov.in/eprocure/app)) by clicking on the link “Click here to Enroll”. Enrolment on the CPP Portal is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their userID / password and the password of the DSC / eToken.

SEARCHING FOR TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, organization name, location, date, value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective ‘My Tenders’ folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

PREPARATION OF BIDS

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.

- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF formats. Bid documents may be scanned with 100 dpi with black and white option.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use “My Space” area available to them to upload such documents. These documents may be directly submitted from the “My Space” area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

SUBMISSION OF BIDS

- 1) Bidder should log into the site well in advance for bid submission so that he/she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 3) Bidder has to select the payment option as “offline” to pay the tender fee / EMD as applicable and enter details of the instrument.
- 4) A standard BoQ format has been provided with the tender document to be filled by all the bidders. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. Bidders are required to download the BoQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.

OR

Financial bids to be submitted in PDF format.

- 5) The server time (which is displayed on the bidders’ dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 6) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done.
- 7) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 8) Upon the successful and timely submission of bids, the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.

ASSISTANCE TO BIDDERS

TECHNICAL SPECIFICATION:

Sl. No.	Technical Specifications
1.	Scanner: i) Large multi-purpose scanner which can scan at least 90 μm x 90 μm . Atomic resolution on graphite or mica must be demonstrated at room temperature. ii) Vertical (Z) noise floor should be <0.05 nm (RMS). Lateral (XY) noise floor should not be more than 1 nm. iii) The creep and hysteresis effect of the scanner must be minimized. The scanner must be able to accurately repeat the image of a sample surface. The creep and hysteresis parameters must be mentioned. iv) The lateral and vertical data should be collected by high quality piezo-electric scanners.
2.	Measurement Modes: i) Contact mode, Non-contact/intermittent contact mode, phase imaging, force-distance spectroscopy, nanoindentation, lateral force microscopy, magnetic force microscopy (MFM) and electrostatic force microscopy (EFM). ii) MFM and EFM modes should have the capability of obtaining interleaved data. First scan should collect topography in non-contact/intermittent contact mode and the second scan should collect magnetic/electrical data from a user specified vertical height. Also, topography and magnetic/electrical images should be visible simultaneously in real time.

3.	<p>Scanning System and Sample Stage:</p> <ul style="list-style-type: none"> i) Scanning system could be tip or sample scanning ii) Direct and non-destructive sample analysis should be possible. iii) A sample size of 35 mm (L) x 35 mm (W) x 15 mm (H) should be measurable.
4.	<p>Optics:</p> <ul style="list-style-type: none"> i) Effective sample navigation to locate the region of interest is required. Optical field of view (FOV) of 1.25 mm-0.25 mm is needed. ii) An on-axis optical microscope of 10x objective lens and color camera with at least 2 μm resolution is needed. iii) Zoom-in on the region of interest should be possible.
5.	<p>Probes and Cantilevers:</p> <ul style="list-style-type: none"> i) Pre-mounted and pre-aligned cantilevers should be provided. ii) Probe holders which can securely hold the tip-cantilever assembly should be provided. iii) Change of cantilevers preferably without the need for changing the scan-head should be possible. iv) At least 30 probes for non-contact mode, 10 probes for contact mode, 20 probes for MFM and 10 probes for EFM should be provided.
6.	<p>Isolation:</p> <p>Effective anti-vibration platform and acoustic enclosure for the SPM must be provided and effectiveness in the system must be demonstrated.</p>
7.	<p>Controller:</p> <ul style="list-style-type: none"> i) Minimum 16-bit digital to analog converters for scan control in the three directions (X, Y and Z). ii) The controller should have an ultra-low noise voltage amplifier (noise limit of 0.4 mV over a 400V scan). iii) The controller should be provided with at least one lock-in amplifier for advanced experiments. iv) The controller should include at least eight 16-bit analog to digital converters which can process high-frequency ac signals. v) The controller should be able to process signals at a sampling rate of at least 100 kHz. vi) The controller should allow access to controller and lock-in signals for customized and advanced experiments.
8.	<p>Workstation computer:</p> <ul style="list-style-type: none"> i) Windows based Operating System with high speed processor. ii) Two LCD monitors to allow for dual PC monitor support.
9.	<p>Maintenance support:</p> <p>Warranty of at least 3 years from the date of installation should be provided.</p>

10.	Sample for calibration: At least one sample should be provided for proper calibration of X, Y and Z scanners.

Sl.No.	Specification
1.	Due date: The tender has to be submitted before the due date. The offers received after the due date and time will not be considered.
2.	Preparation of Bids: Financial Bids to be submitted in PDF format. The Technical bid and the financial bid should be submitted Online in 2 Envelope.
3.	EMD: The tenderer should submit an EMD amount by way of Demand Draft/BG/Banker's Pay Order drawn in favour of " Registrar, Indian Institute of Technology, Delhi " and payable at New Delhi from any nationalized bank valid for six months. The Technical Bid without EMD would be considered as UNRESPONSIVE and will not be accepted. The EMD will be returned without any interest to the unsuccessful bidders immediately after the award of contract.
4.	Refund of EMD: The EMD will be returned to unsuccessful Tenderer only after the Tenders are finalized. In case of successful Tenderer, it will be retained till the successful and complete installation of the equipment.
5.	Opening of the tender: The online bid will be opened by a committee duly constituted for this purpose. Online bids (complete in all respect) received along with Demand Draft/ Bankers Cheque of EMD (Physically) will be opened as mentioned at "Annexure: Schedule" in presence of bidders representative if available, Only one representative will be allowed to participate in the tender opening. Bid received without EMD will be rejected straight way. The technical bid will be opened online first and it will be examined by a technical committee which will decide the suitability as per our specification and requirement. The financial offer/bid will be opened only for the offer/bid which technically meets all our requirements as per the specification, and will be opened in the presence of the vendor's representatives subsequently for further evaluation. The bidders if interested may participate on the tender opening Date and Time. The bidder should produce authorization letter from their company to participate in the tender opening.
6.	Acceptance/ Rejection of bids: The Committee reserves the right to reject any or all offers without assigning any reason.
7.	Pre-qualification criteria: (i) Bidders should be the manufacturer / authorized dealer. Letter of Authorization from original equipment manufacturer (OEM) on the same and specific to the tender should be enclosed. (ii) An undertaking from the OEM is required stating that they would facilitate the bidder on a regular basis with technology/product updates and extend support for the warranty as well. (iii) OEM should be internationally reputed Branded Company. (iv) Non-compliance of tender terms, non-submission of required documents, lack of clarity of the specifications, contradiction between bidder specification and supporting documents etc. may lead to rejection of the bid.
8.	Performance Security: The supplier shall require to submit the performance security in the form of irrevocable bank guarantee issued by any Indian Nationalized Bank for an amount which is equal to the 5% of FOB value within 21 days from the date of receipt of the purchase order and should be kept valid for a period of 60 days beyond the date of completion of warranty period.
9.	Force Majeure: The Supplier shall not be liable for forfeiture of its performance security, liquidated damages or termination for default, if and to the extent that, it's delay in performance or other failure to perform its obligations under the Contract is the result of an event of Force Majeure. <ul style="list-style-type: none"> For purposes of this Clause, "Force Majeure" means an event beyond the control of the Supplier and not involving the Supplier's fault or negligence and not foreseeable. Insurance: For delivery of goods at the purchaser's premises, the insurance shall be obtained by the Supplier in an amount equal to 110% of the value of the goods from "warehouse to warehouse" (final destinations) on "All Risks" basis including War Risks and Strikes. The insurance shall be valid for a period of not less than 3 months after installation and commissioning. In case of orders placed on FOB/FCA basis, the purchaser shall arrange Insurance. If orders placed on CIF/CIP basis, the insurance should be up to IIT Delhi.
