Background: Plasma Physics Lab of DESE, IIT Delhi undertakes experiments in custom-designed high vacuum, plasma chambers (SS304 / SS316) for academic and research purposes.

Aims & Objectives: Department of Energy Science and Engineering (DESE), Indian Institute of Technology Delhi (IIT Delhi) invites offline bids for Large Volume Vacuum Chamber assembly as per custom design.

The manufacturer shall perform the scope of works required by this specification which includes (but is not limited to): the supply of materials, all tooling, the detailed manufacturing and assembly drawings, equipment required for the manufacturing, handling, testing, manufacturing, cleaning, inspection, vacuum conditioning, testing, packing and the delivery of the vacuum chambers to DESE, IIT Delhi.
- 1.3. This call for tender covers the supply of a customized SS-316 vacuum chamber with different vacuumcompatible sections and cooling channels (a prototype).
- 1.4. The bidders are requested to comment upon the specification and are encouraged to make alternative proposals to DESE, IIT Delhi in addition to the quotation for the given specification. The suggested alternatives to the design (if any error is there) and fabrication methods are to improve the technical performances, cost saving, or to have a reduction in delivery time.
- 1.5. After the contract has been placed, any deviations or modifications from the agreed specification will not be allowed, except with the written authorization of DESE, IIT Delhi.
- 1.6. The manufacturer must deliver to IIT Delhi:
- 1.6.1. The specified vacuum chamber sections that are able to provide high vacuum ~ 10^{-6} Torr to 10^{-7} Torr.
- 1.6.2. The manufacturer must follow the time schedule of this specification.
- 1.6.3. The manufacturer must prepare a detailed time schedule showing all the activities related to the fabrication and the contract.

- 1.6.4. Detailed and complete set of assembly and manufacturing drawings of the vacuum chambers, the format, and the standards of the manufacturing drawings to be agreed with IIT Delhi.
- 1.6.5. Detailed and complete set of manufacturing drawings for the dedicated tooling or types of equipment to be used for the manufacturing, assembly, and testing.
- 1.6.6. The manufacturer shall provide a list of equipment that will be used for the manufacturing, certificates of control of some equipment that could be required, and to be agreed upon with IIT Delhi.
- 1.6.7. The welding and vacuum brazing plan and drawings.
- 1.6.8. The quality plan and the quality schedule.
- 1.6.9. A complete set of procurement documents for materials and bought-in items is to be sent to DESE, IIT Delhi as soon as it is ready, and in addition, a copy of the order is to be sent to IIT Delhi at the time of ordering.
- 1.6.10. A complete set of manufacturing, cleaning, and testing procedure. In case different manufacturing, cleaning, and testing procedure have been suggested from that proposed by DESE, IIT Delhi then a complete set of manufacturing, cleaning, and testing procedures is required and they have to be approved by DESE, IIT Delhi.
- 1.6.11. A complete set of test certificates, factory acceptance test results, and inspection reports as required by this specification as they become available and a complete set in the form of a documentation file at the end of the contract. This documentation file shall include the results of the material, details of the degassing procedure (pressure and temperature vs. time), results of leak tests after welding, results of the dimensional control, and leakage rate of the completed chamber.
- 1.6.12. Reports of non-conformity of the vacuum chambers (if any).
- 1.6.13. The vacuum chamber must be supplied to DESE, IIT Delhi with the material certificate, the production file, the Inspection Points Plan (IPP) documentation, Welding Procedure Specifications (WPS), test reports, the cleaning report, and the Quality Assurance Plan (QAP) results.
- 1.6.14. DESE, IIT Delhi has the property right for all the tooling as also the manufacturing drawings.

Other Essential Terms and Conditions:

- Custom designs are only to be provided to the L1 bidder after signing a Non-Disclosure Agreement (NDA). Only those willing to sign this agreement at the final stage of bidding are eligible to participate. Although a rough schematic diagram will be provided to bidders on request.
- Travel and accommodation budget for supervision visits to the fabrication location are to be borne by the bidder.

Number of Visits: 2 (minimum) by 2 personnel. Stages:

First Visit: Once components have been procured and machined before any welding processes are initiated.

Second Visit: When all sections are fabricated and a vacuum compatibility check is to be carried out.

The successful bidder will also have to demonstrate the vacuum compatibility (~ 10^{-6} to 10^{-7} Torr) after delivery at DESE, IITD.

Proof of Purchase Orders to be provided that have shown similar job works in vacuum-compatible large volume/ area systems.

Evaluation Criteria and Method of Evaluation:

1. Screening of bids shall be carried out as per eligibility conditions mentioned in this document and based on verification of testimonials submitted.
