TERMS AND CONDITIONS

1. The work shall be carried out as per CPWD specifications for HVAC work & manufacture's recommendation.
2. The rates quoted by the tenderer, shall be firm and inclusive of all taxes (including GST), duties & levies, octroi etc. and all charges for packing forwarding, insurance, freight and delivery, installation, testing, commissioning etc. at site including risk, overhead charges, general liabilities / obligations and clearance from concerned authority, if any.
3. Payment shall be made after completion of work followed by submission of bill.
4. Nothing shall be paid extra in labour / material rates
5. For substandard work penalty may be imposed and suitable recovery will be made from bill of the contractor.
6. No advance payment will be made to the contractor.
7. Storage of materials inside the IIT Campus is strictly prohibited.
8. Material should be shown to the Engineer-in-charge before installation.
9. Work shall be carried out as per direction and to the entire satisfaction of the Engineer-in-charge.
10. Incomplete work will be got done at the risk and cost to the contractor.
11. No T&P shall be issued by the Institute and the contractor has to make his own arrangement
12. Necessary compensation as per clause IITD 7 / 8 as applicable, MAY BE IMPOSED IF REQUIRED.
13. The contractor shall be responsible for any injury or accident to the labour working at site and no claim shall be given by the Institute.
14. Necessary Taxes as applicable shall be deducted from bill of the contractor.
15. Use of correction fluid in quotation / tender document not to be allowed. Such quotation / tender is liable to be rejected.
16. Non judicial stamp paper worth Rs.10/- will be sent for completion of work order which will have to be signed in token of acceptance.
17. GST is reimbursable on production of proof or submission.
18. SD @5% shall be deducted on quoted amount and shall be released after one year of defect liability period.
