Instructions for Online Bid Submission:

As per the directives of Department of Expenditure, this tender document has been published on the Central Public Procurement Portal ([URL:http://eprocure.gov.in/eprocure/app](http://eprocure.gov.in/eprocure/app)). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal ([URL:http://eprocure.gov.in/eprocure/app](http://eprocure.gov.in/eprocure/app)) by clicking on the link “Click here to Enroll”. Enrolment on the CPP Portal is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / eToken.

SEARCHING FOR TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active tenders by several parameters. These parameters could include Tender ID, organization name, location, date, value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a tender published on the CPP Portal.
- 2) Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. These tenders can be moved to the respective ‘My Tenders’ folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- 3) The bidder should make a note of the unique Tender ID assigned to each tender, in case they want to obtain any clarification / help from the Helpdesk.

PREPARATION OF BIDS

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the

bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.

- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF formats. Bid documents may be scanned with 100 dpi with black and white option.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use “My Space” area available to them to upload such documents. These documents may be directly submitted from the “My Space” area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

SUBMISSION OF BIDS

- 1) Bidder should log into the site well in advance for bid submission so that he/she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 3) Bidder has to select the payment option as “on-line” to pay the tender fee / EMD as applicable and enter details of the instrument. Whenever, EMD / Tender fees is sought, bidders need to pay the tender fee and EMD separately on-line through RTGS (Refer to Schedule, Page No.2).
- 4) A standard BoQ format has been provided with the tender document to be filled by all the bidders. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. Bidders are required to download the BoQ file, open it and complete the white colored (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BoQ file is found to be modified by the bidder, the bid will be rejected.

OR

In some cases Financial Bids can be submitted in PDF format as well (in lieu of BOQ).

- 5) The server time (which is displayed on the bidders’ dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 6) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done.
- 7) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.
- 8) Upon the successful and timely submission of bids, the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 9) Kindly add scanned PDF of all relevant documents in a single PDF file of compliance sheet.

TECHNICAL SPECIFICATION:

Sl. No.	Technical Specifications
	Microfiltration device (Quantity:1) specifications are as follows:
1.1	The construction should be of SS 316L (vessels, tubing and clamps). The gaskets should be of EPDM, Viton or material of equivalent quality. The device should be mounted on a sturdy skid (SS 304) with support rods and clamps to hold the system steady. The skid should be mounted on lockable casters. The total height of the equipment should not exceed 2m.
1.2	A feed reservoir vessel of 50l capacity having a height/diameter ratio of 4-5 (e.g. 0.25m x 1m). The vessel should have a conical bottom with a free-standing baffle (steel plate with holes) to prevent swirling. The vessel should have a jacket (preferably dimpled) for temperature control via circulation of hot/cold water. There should be a layer of thermal insulation around the jacketed vessel. The feed outlet should also be at the bottom of the vessel.
1.3	The tubing should have an internal diameter of 1.5" and should be able to withstand up to 6 bar pressure and 90 °C temperature. All connections should have triclover fittings with gaskets and clamps. There should be a bypass line between the inlet and the outlet of the pump.
1.4	The head plate should have three openings. The 1.5" recycle tube should have hose barbs on one end and a 45° cut on the other end. The recycle tube should be able to slide through the recycle port. The recycle port should have a clamp for firmly holding the recycle tube in place.
1.5	There should be on/off valve for drainage at the lowest point in the tubing upstream of the pump.
1.6	Three needle valve flow regulators: (a) at module outlet, (b) at pump bypass and (c) on a T-junction in the

	bypass line.
1.7	A centrifugal pump with a nominal flow rate of 100 l/min. The pump should be able to operate at back pressures up to 6 bars and temperatures up to 90 °C. The pump and motor should generate minimum noise and vibration.
1.8	Two pressure gauges having a measurement range of 0.1 - 5 bar: (a) at module inlet and (b) at module outlet.
1.9	Two pressure gauges having a measurement range of 0.1 - 2 bar: (a) at upstream permeate outlet and (b) at downstream permeate outlet.
1.10	One temperature gauge having a measurement range of 10 to 90°C at the module outlet.
1.11	A magnetic flow meter in the retentate line having a flowrate measurement range of 10 – 100 l/min.
1.12	Universal housing for Pall Membralox EP1940 (1020mm) ceramic membrane with 1.5" triclover connections at either end (adaptors with triclover connections required if the pipe dimension at the seat of gasket > 1.5"). The top and bottom permeate tubes should have ¾" triclover ferrules.
1.13	A DC Pump with a maximum flow rate of 20 l/min and a voltage regulator for adjusting flow rate. Push lock type closure (16mm) at the inlet and the outlet ports.
1.14	A 2 liter jacketed cylindrical vessel having a feed outlet at the bottom with a push lock type closure (16mm). There should be a discharge tube perpendicular to the tank surface at a height such that any fluid inside the tank in excess of 1 liter spills out of the tube. There should be support rods to hold the vessel firmly in place. Adaptors for the two permeate ports with ¾" triclover ferrules on side and push lock type closure (16mm) on the other side. 5m roll of 16mm polyurethane tubing.

	Ultrafiltration device (Quantity:2) specifications are as follows:
2.1	Two identical devices need to be fabricated having the specifications as mentioned in the following points.
2.2	The construction should be of SS 316L (vessels, tubing and clamps). The gaskets should be of EPDM, Viton or material of equivalent quality. The device should be mounted on a sturdy skid (SS 304) with support rods and clamps to hold the system steady. The skid should be mounted on lockable casters. The total height of the equipment should not exceed 2m.
2.3	A feed reservoir vessel of 25l capacity having a height/diameter ratio of 4-5 (e.g. 0.2m x 0.8m). The vessel should have a conical bottom with a free-standing baffle (steel plate with holes) to prevent swirling. The vessel should have a jacket (preferably dimpled) for temperature control via circulation of hot/cold water. There should be a layer of thermal insulation around the jacketed vessel. The feed outlet should also be at the bottom of the vessel.
2.4	The tubing should have an internal diameter of 0.75" and should be able to withstand up to 40 bar pressure and 80 °C temperature. All connections should have triclover fittings (0.75") with gaskets and clamps. There should be a bypass line between the inlet and the outlet of the pump.
2.5	The head plate should have three openings. The 0.75" recycle tube should have hose barbs on one end and a 45° cut on the other end. The recycle tube should be able to slide through the recycle port. The recycle port should have a clamp for firmly holding the recycle tube in place.
2.6	There should be on/off valve for drainage at the lowest point in the tubing upstream of the pump.
2.7	Two needle valve flow regulators: (a) at pump bypass and (b) at module outlet.
2.8	A positive displacement feed pump (piston/diaphragm) with a nominal flow rate of 20 - 30 l/min. The pump should have a multiple head design to achieve pulse-less flow. The pump should be able to operate at back

	pressure up to 40 bar and temperature up to 80 °C. The pump and motor should generate minimum noise and vibration.
2.9	The motor should have a variable frequency drive for speed regulation.
2.10	Two piezoelectric/metal thin film pressure transducers having a measurement range of 0.1 - 40 bar: (a) at module inlet and (b) at module outlet.
2.11	One clamp type temperature sensor at the module inlet having a measurement range of 10 to 80 °C.
2.12	A magnetic flow meter in the retentate line having a flowrate measurement range of 3 – 30 l/min.
2.13	Housing with triclover type connections for the following type of spiral wound membranes: (a) Female type 1812, (b) Male type 2012, (c) Male type 2540.
2.14	The control panel should display data from all digital sensors and have the variable frequency drive setting for the motor. It should also have alarm and auto shut off for excess pressure, extreme temperature and power fluctuation.

1.	Due date: The tender has to be submitted on-line before the due date. The offers received after the due date and time will not be considered. No manual bids will be considered.
2.	Preparation of Bids: The offer/bid should be submitted in two bid systems (i.e.) Technical bid and financial bid. The technical bid should consist of all technical details along with commercial terms and conditions. Financial bid should indicate item wise price for the items mentioned in the technical bid in the given format i.e Financial Bids to be submitted in PDF format. The Technical bid and the financial bid should be submitted Online.
3.	Opening of the tender: The online bid will be opened by a committee duly constituted for this purpose. Online bids (complete in all respect) received along with EMD (if any) will be opened as mentioned at “Annexure: Schedule” in presence of bidders representative if available. Only one representative will be allowed to participate in the tender opening. Bid received without EMD (if present) will be rejected straight way. The technical bid will be opened online first and it will be examined by a technical committee (as per specification and requirement). The financial offer/bid will be opened only for the offer/bid which technically meets all requirements as per the specification, and will be opened in the presence of the vendor’s representatives subsequently for further evaluation. 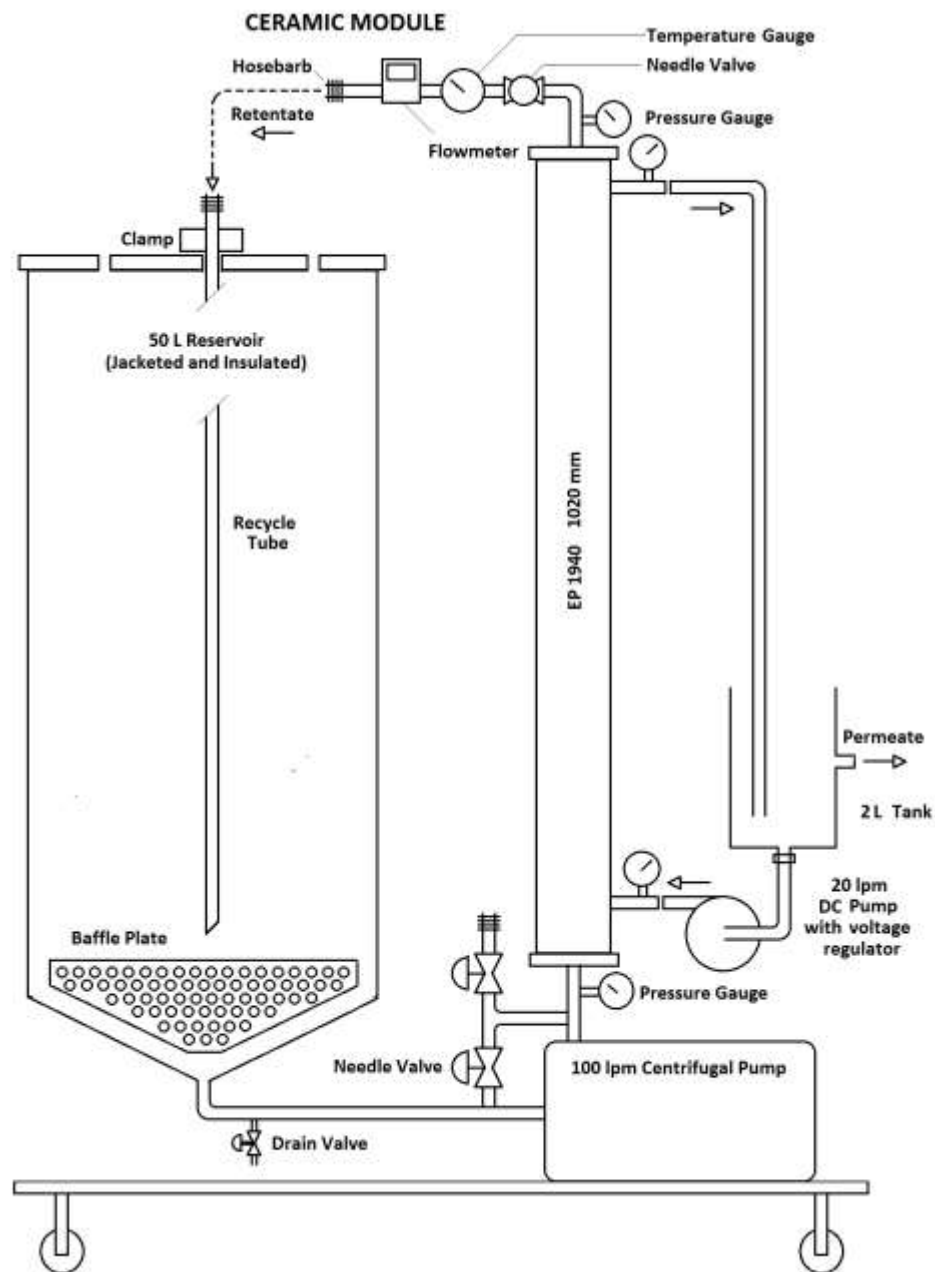


Figure 1: Microfiltration Device (Quantity:1)

SPIRAL WOUND MODULE

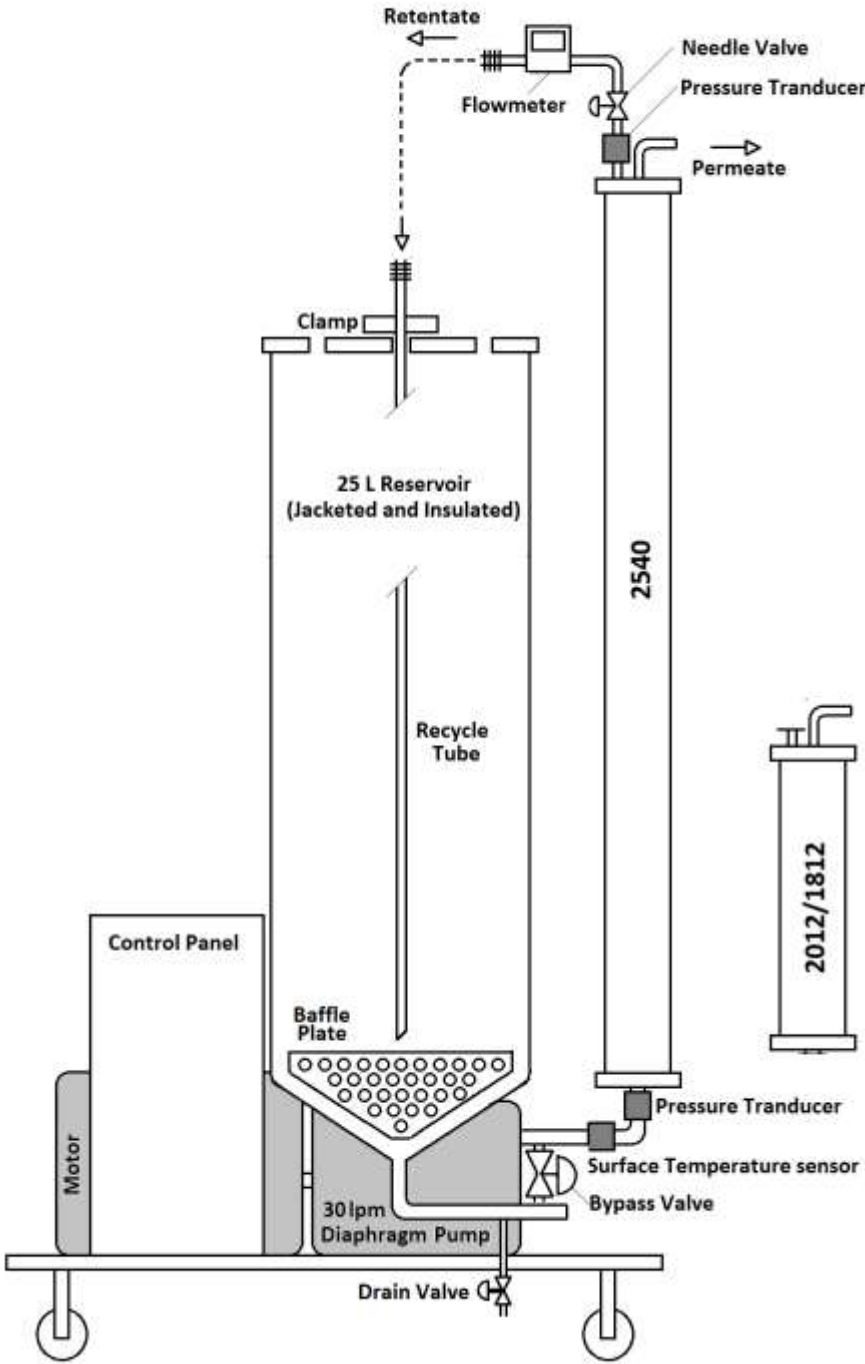


Figure 2: Ultrafiltration Device (Quantity:2)
