Applications in person for issue of tenders shall accompany the following: -


1. Cost of tender ₹ 500/- (₹ Five Hundred Only) in cash deposit in S.B.I. or Canara Bank at IIT Delhi.(Non- refundable)
2. Earnest money amounting to ₹ 13,524/- (₹ Thirteen Thousand Five Hundred Twenty Four Only) in the form of Banker's Cheque or Demand Draft drawn in favour of IIT Delhi. (at the time of tender)
3. Attested valid TIN Registration Certificate under D-VAT (including deposit receipt etc.)
4. Completion Certificates issued by an officer not below the rank of Executive Engineer of similar works completed by the Agency.
5. Registration of firms / Contractors must be valid on the last day of issue of Tenders. (if applicable)
6. Work means only work under Government/ Public Sector Under taking/ Autonomous Bodies.
7. Similar work means any Civil work such as Renovation/ Addition/ Modification/ Alteration/ Maint. of New Construction of building work.
8. Tenders shall be submitted in the prescribed manner in Sealed Cover.
