As per the directives of Department of Expenditure, this tender document has been published on the Central Public Procurement Portal (URL:http://eprocure.gov.in/eprocure/app). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. REGISTRATION

- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.


