## **INSTRUCTIONS FOR ONLINE BID SUBMISSION**

As per the directives of Department of Expenditure, this Quotation / tender document has been published on the Central Public Procurement Portal ([URL:http://eprocure.gov.in/eprocure/app](http://eprocure.gov.in/eprocure/app)). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

### **REGISTRATION**

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal ([URL:http://eprocure.gov.in/eprocure/app](http://eprocure.gov.in/eprocure/app)) by clicking on the link "Click here to Enroll". Enrolment on the CPP Portal is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

### **SEARCHING FOR QUOTATION /TENDER DOCUMENTS**

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active Quotations / Tender by several parameters. These parameters could include Quotation ID, organization name, location, date, value, etc. There is also an option of advanced search for Quotations, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a Quotation published on the CPP Portal.
- 2) Once the bidders have selected the Quotations they are interested in, they may download the required documents / Quotation schedules. These Quotations can be moved to the respective 'My Quotations' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the Quotation document.
- 3) The bidder should make a note of the unique Quotation ID assigned to each Quotation / Tender, in case they want to obtain any clarification / help from the Helpdesk.

### **PREPARATION OF BIDS**

- 1) Bidder should take into account any corrigendum published on the Quotation document before submitting their bids.
- 2) Please go through the Quotation / Tender advertisement and the Quotation / Tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in

which the bid documents have to be submitted, the number of documents - including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.

- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the Quotation document / schedule and generally, they can be in PDF / XLS / RAR / DWF formats. Bid documents may be scanned with 100 dpi with black and white option.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

### **SUBMISSION OF BIDS**

- 1) Bidder should log into the site well in advance for bid submission so that he/she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the Quotation document.
- 3) Bidder has to select the payment option as "offline" to pay the Quotation fee / EMD as applicable and enter details of the instrument.
- 4) A standard BOQ format has been provided with the Quotation document to be filled by all the bidders. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. Bidders are required to download the BOQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

OR

In some cases Financial Bids can be submitted in PDF format as well (in lieu of BOQ).

- 5) The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 6) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done.
- 7) The uploaded Quotation documents become readable only after the Quotation opening by the authorized bid openers.
- 8) Upon the successful and timely submission of bids, the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 9) Kindly add scanned PDF of all relevant documents in a single PDF file of compliance sheet.

3. **Similar work means Operation & Maintenance of fixed fire installations.**

Item rate tenders are invited on behalf of The Board of Governors, IIT Delhi, Hauz Khas, New Delhi - 110016 from Firms/ Contractors registered in appropriate class and category with CPWD, MES, BSNL dealing with **Operation & Maintenance of fixed fire installations** as per details given below for the work of **A.R & M.O Fire Fighting Equipments at IIT Delhi. SH:-Operation, Running Maintenance and testing of Fire Detection & Fire Fighting Equipments in different building at IIT Delhi.**

- 1.1 The work is estimated to cost **Rs. 51,84,648.00** This estimate, however, is given merely as a rough guide
  - 1.1.1 The authority competent to approve NIT for the combined cost and belonging to the major discipline will consolidate NITs for calling the bids. He will also nominate Division which will deal with all matters relating to the invitation of bids.

For composite bid, besides indicating the combined estimated cost put to tender, should clearly indicate the estimated cost of each component separately. The eligibility of bidders will correspond to the combined estimated cost of different components put to bid.
- 1.2 Intending bidder is eligible to submit the bid provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below:-

### Criteria of eligibility for submission of bid documents.

#### 1.2.1 Criteria of eligibility for CPWD as well as non-CPWD contractors.

Three similar works each of value not less than **Rs. 20,73,860.00** or two similar work each of value not less than **Rs. 31,10,789.00** or one similar work of value not less than **Rs. 41,47,719.00** in last 7 years ending previous day of last date of submission of bids.

#### 1.2.2 To become eligible for issue of bid, the bidders shall have to furnish an affidavit as under :-

"I / We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I / We shall be debarred for bidding in IIT Delhi in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee (Scanned copy to be uploaded at the time of submission of bid)"

2. **Agreement shall be drawn with the successful bidders on prescribed Form No. IITD 7/8 which is available as IIT Delhi Publication. Bidders shall quote their rates as per various terms and conditions of the said form which will form part of the agreement.**

AND WHEREAS the Principal/Owner values full compliance with all relevant laws of the land, rules, regulations, economic use of resources and of fairness/transparency in its relation with its Bidder(s) and Contractor(s).AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement (hereinafter referred to as "**Integrity Pact**" or "**Pact**"), the terms and conditions of which shall also be read as integral part and parcel of the Tender/Bid documents and Contract between the parties.

NOW, THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as under:

**Article 1: Commitment of the Principal / Owner**

- 3) If the Principal/Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal code (IPC)/Prevention of Corruption Act, 1988 (PoC Act) or is in violation of the principles herein mentioned or if there be a substantive suspicion in this regard, the Principal/Owner will inform the Chief Vigilance Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

## **Article 2: Commitment of the Bidder(s) / Contractor(s)**

- 1) It is required that each Bidder/Contractor (including their respective officers, employees and agents) adhere to the highest ethical standards, and report to the Government / Department all suspected acts of **fraud or corruption or coercion or collusion** of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.
- 2) The Bidder(s)/Contractor(s) commits himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:

- 3) The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- 4) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm indulge in fraudulent practices **means a willful misrepresentation or omission of facts or submission of fake/forged documents in order to induce public official to act in reliance thereof, with the purpose of obtaining unjust advantage by or causing damage to justified interest of others and/or to influence the procurement process to the detriment of the Government interests.**
- 5) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may befall upon a person, his/her reputation or property to influence their participation in the tendering process).

### **Article 3: Consequences of Breach**

The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/Owner. **Such exclusion may be forever or for a limited period as decided by the Principal/Owner.**

### **1 COMMERCIAL CONDITIONS**

**1.1** Type of contract

The work to be awarded by this tender shall be treated as indivisible works contract.

**1.2** Submission of Tender:-

    - d) The replacement of defective/damaged heat/smoke detector, response indicator, hooters batteries, hose reel, hose reel drums, hydrants, F.B. inlets, rewinding of motors will be carried out as per list enclosed ( Annexure - A) with written consent of Engineer- in - charge. The cost of all such item will be paid on actual completion of the works on the basis of the bill to be submitted by the contractor with 15% profit.
    - e) Any damage caused to the site or to equipment or any Institute's property shall be made good by the Contractor at his own risk and cost.
    - f) Log books and stationery as required shall be supplied and maintained by the contractor for Wet Riser System, Fire Alarm Systems and P.A. Systems.
    - g) Labour report showing the persons employed by the contractor shall be given to the E.E (Elect.)/S.O quarterly. There shall be no liability on the part of the Institute to pay any compensation arising out of the labour dispute due to accident etc. at site. The contractor will be fully responsible for all such defaults.
    - h) The contractor shall not dismantle and remove any items without the knowledge of Engineer- in - charge. Dismantled material shall be the property of Institute.
    - i) The contractor's staff shall mark their attendance in the attendance register daily.
    - j) Contractor will visit the site on alternate days and as and when called by the Engineer- in - charge. On his visit he should meet Engineer- in - charge and will report about the satisfactory working of all equipments.
    - k) The performance of the Contractor's work shall be reviewed by IITD authorities twice in a month wherein senior executive other than the supervisor of the contracting firm will also be present. In case of any breakdown, the frequency of such review may even increase.

**5. DURATION OF CONTRACT :-**

The contract will be valid for 12 Months i.e. from **01/04/2019**.

**6. SAFETY OF MEN AND MATERIAL :-**

- a) The contractor will be responsible not only for his own men & material but also for the security of equipments/materials of the Institute. The cost of repairs/replacement of equipment damage due to mishandling by the staff of the contract will be deducted from contractor's bill after assessment by Engineer- in - charge. The assessment of Engineer- in - charge will be final and binding on the contractor.

**8. PENALTY/RECOVERY:-****a) DUE TO NON AVAILABILITY OF STAFF & LONGER BREAKDOWNS**

In case if the required staff is not present in any of the shift due to any reason, recovery shall be made from the bill in accordance with Clause 19 as above.

**b) WET RISER**

A sum of Rs.5000/- shall be recovered if any of the equipment i.e. Pump, Wet Riser system is not operative on account of any fault continuously for a period of more than 05 (five) days. If the fault rectification is likely to take time on account of any reason beyond the control of the contractor, then the firm must confirm in writing to the Engineer- in - charge. The recovery amount can be waived off if the reason for delay given by the contractor is found satisfactory. The decision of the Engineer- in - charge shall be final.

**c) FIRE ALARM CUM DETECTION SYSTEM AND TALK BACK & P.A. SYSTEM**

Recovery of Rs.1000/- per zone per day will be made for delay of more than 24 hrs. in rectification of the breakdown of any of the Public Address system as well as fire alarm system.

- (a) Institute shall provide suitable space for the sitting of the staff of the contractor. Required furniture is to be arranged by the contractor. Institute will not be responsible for any misplacement or damage or theft of the contractor's equipment, or any other articles.

**5. YEARLY CHECK:**

- b) Any other jobs as instructed by the Maintenance In-charge for maintenance & operation of fire fighting system not mentioned above. The contractor should call the manufacturer's representative at his cost, in case he is not able to rectify the defects & or on any other such accessories where expert advice is required.
