## **INSTRUCTIONS FOR ONLINE BID SUBMISSION**

As per the directives of Department of Expenditure, this quotation / tender document has been published on the Central Public Procurement Portal (URL: <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a>). The bidders are required to submit softcopies of their bids electronically on the CPP portal, using valid Digital Signature Certificates (DSC). The instructions given below are meant to assist the bidders in registering on the CPP portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP portal.

More information useful for submitting online bids on the CPP portal may be obtained at http://eprocure.gov.in/eprocure/app

#### REGISTRATION

- 1. Bidders are required to enrol on the e-procurement module of the Central Public Procurement portal (URL: <a href="http://eprocure.gov.in/eprocure/app">http://eprocure.gov.in/eprocure/app</a>) by clicking on the link, "click here to enrol". Enrolment on the CPP portal is free of charge.
- 2. As part of the enrolment process, the bidders will be required to choose a unique user name and assign a password for their accounts.
- 3. Bidders are advised to register their valid e-mail address and mobile number as part of the registration process. These would be used for any communication from the CPP Portal.
- 4. Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (class 2 or class 3 certificates with signing key usage) issued by any certifying authority recognised by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.) with their profile.
- Only one valid DSC should be registered by a bidder. Please note that bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
- 6. Bidder then logs into the site through the secured log-in by entering their user ID / password and the password of the DSC / eToken.

#### SEARCHING FOR TENDER DOCUMENTS

1. There are various search options built in the CPP portal to facilitate bidders to search active tenders by several parameters. These parameters could include tender ID, organisation name, location, date, value, etc. There is also an option of advanced search for tenders, wherein the bidders may combine a

number of search parameters such as organisation name, form of contract, location, date, other keywords etc. to search for a tender published on the CPP portal.

- 2. Once the bidders have selected the tenders they are interested in, they may download the required documents / tender schedules. The tenders can be moved to the respective "My Tenders" folder. This would enable the CPP portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the tender document.
- 3. The bidder should make a note of the unique Tender ID assigned to each other, in case they want to obtain any clarification / help from the Helpdesk.

#### PREPARATION OF BIDS

- 1. Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2. Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bids. Please note the number of covers in which the bid documents have to be submitted. Any deviations from these may lead to rejection of the bids.
- 3. Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF formats. Bid documents may be scanned with 100 dpi with black & white option.
- 4. To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor's certificates, etc.) has been provided to the bidders. Bidders can use "My Space" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

#### SUBMISSION OF BIDS

- 1. Bidder should log into the site well in advance for bid submission so that he / she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2. The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- Bidder has to select the payment option as "on-line" to pay the tender fee / EMD as applicable and enter details of the instrument. Whenever, EMD / Tender fees is sought, bidders need to pay the tender fee and EMD separately online through RTGS (Refer to Schedule, Page no. 3)

4. A standard BOQ Format has been provided with the tender document to be filled by all the bidders. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. Bidders are required to download the BOQ file, open it and complete the white coloured [unprotected] cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

OR

In some cases financial bids can be submitted in PDF format as well (in lieu of BOQ).

- 5. The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.
- 6. All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorised persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done.
- 7. The uploaded tender documents become readable only after the tender opening by the authorised bid openers.
- 8. Upon the successful and timely submission of bids, the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 9. Kindly add scanned PDF of all relevant documents in a single PDF file of compliance sheet.

- 1. The successful bidder shall be required to submit a performance guarantee of 5% of the tendered amount in the form of Bank Guarantee or F.D.R. from a Nationalized / Scheduled Bank within fifteen days of issue of letter of intent before award of work. In case of failure by the Contractor to submit the performance guarantee within the specified period, full earnest money will be forfeited by the Institute and the tender shall be treated as null and void. - 3. Earnest money (EMD) shall have to be deposited / submitted as stipulated in the schedule.
- 4. The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of submission of financial bid.
- 5. Similar work means: Annual Operation and Maintenance of D.G. Sets.
- 6. Work means work done with some Central Government Department / State Government Department / Central Autonomous Body / State Autonomous Body / Central Public Sector Undertaking / City Development Authority / Municipal Corporation of City formed under any Act by Central / State Government and published in Central / State Gazette.
- 7. Completion certificates are required to be got issued by an officer not below the rank of Executive Engineer of similar works completed by the Firm. The work experience certificates submitted by the bidders shall clearly indicate that:

  - c. Actual date of completion of the work
- 8. IITD is committed to follow the principle of transparency, equity and competitiveness in public procurement. Before submission of bid, each bidder should sign integrity pact at respective places and submit the bid. If duly signed integrity pact is not submitted by bidder, such bid shall not be considered.
- 9. The intending bidder must read the terms and conditions [both commercial & Additional] & IITD 6 carefully which will be the part of the Contract. He should only submit his bid if he considers himself eligible and he is in possession of all the documents required.
- **10.** Information and Instructions for bidders posted on website shall form part of bid document.
- 11. The bid document consisting of plans, specifications, the schedule of quantities of various types of items to be executed and the set of terms and conditions of the contract to be complied with and other necessary documents can be seen and downloaded from website e-procure.gov.in free of cost.
- **12.**But the bid can only be submitted after submission of EMD as prescribed in the schedule.
- 13. Copy of all mandatory documents as desired in the NIT shall be scanned and up-loaded to the e-Tendering website within the period of bid submission. However, certified / original copy of all the scanned and up-loaded documents shall have to be submitted by the lowest bidder only within a week physically in the office of e-tendering authority. During scrutiny of technical bids, if required, bidders may be asked to submit original documents for cross checking.

- **17.** The department reserves the right to reject any prospective application without assigning any reason and to restrict the list of qualified contractors to any number deemed suitable by it, if too many bids are received satisfying the laid down criterion.
- **18.** Contractors must ensure to quote rate of each item.
- 19. - **1.1** The work is estimated to cost Rs.**25**,**72**,**800**.**00**. This estimate, however, is given merely as a rough guide.
- 1.1.1 The authority competent to approve NIT for the combined cost and belonging to the major discipline will consolidate NITs for calling the bids. He will also nominate Division which will deal with all matters relating to the invitation of bids.
- 1.2 Intending bidder is eligible to submit the bid provided he has definite proof from the appropriate authority, which shall be to the satisfaction of the competent authority, of having satisfactorily completed similar works of magnitude specified below:-
- 1.2.1 Criteria of eligibility for submission of bid documents: Conditions for intending bidders / contractors

The value of executed work shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to last date of submission of financial bid.
- 1.2.2 To become eligible for issue of bid, the bidders shall have to furnish an affidavit as under: "I / We undertake and confirm that eligible similar works(s) has/have not been got executed through another contractor on back to back basis. Further that, if such a violation comes to the notice of Department, then I / we shall be debarred for bidding in IIT Delhi in future forever. Also, if such a violation comes to the notice of Department before date of start of work, the Engineer-in-Charge shall be free to forfeit the entire amount of Earnest Money Deposit/Performance Guarantee (Scanned copy to be uploaded at the time of submission of bid)"

WHEREAS the Principal / Owner has floated the Tender (NIT No. 0827/64/IITD/EW/EE(ED-1)/2025-26) (hereinafter referred to as "Tender/Bid") and intends to award, under laid down organizational procedure, contract for "Round the clock operation of 4 x 2000 KVA HT DG sets in IIT Delhi."

(Name of work) hereinafter referred to as the "Contract".

AND WHEREAS the Principal/Owner values full compliance with all relevant laws of the land, rules, regulations, economic use of resources and of fairness/transparency in its relation with its Bidder(s) and Contractor(s) AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement (hereinafter referred to as "Integrity Pact" or "Pact"), the terms and conditions of which shall also be read as integral part and parcel of the Tender/Bid documents and Contract between the parties.

NOW, THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as under:

#### ARTICLE 1: COMMITMENT OF THE PRINCIPAL / OWNER

- 1. The Principal/Owner commits itself to take all measures necessary to prevent corruption and to observe the following principles:
  - 1.1. No employee of the Principal / Owner, personally or through any of his / her family members, will in connection with the Tender, or the execution of the Contract, demand, take a promise for or accept, for self or third person, any material or immaterial benefit which the person is not legally entitled to.

If the Principal/Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal code (IPC)/Prevention of Corruption Act, 1988 (PoC Act) or is in violation of the principles herein mentioned or if there be a substantive suspicion in this regard, the Principal/Owner will inform the Chief Vigilance Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

#### ARTICLE 2: COMMITMENT OF THE BIDDER(S) / CONTRACTOR(S)

- 1. It is required that each Bidder/Contractor (including their respective officers, employees and agents) adhere to the highest ethical standards, and report to the Government / Department all suspected acts of fraud or corruption or coercion or collusion of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.
- 2. The Bidder(s)/Contractor(s) commits himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:

This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to cartelize in the bidding process.
  - **2.3.** The Bidder(s) / Contractor(s) will not commit any offence under the relevant IPC/PoC Act. Further the Bidder(s) / Contractor(s) will not use improperly, (for the purpose of competition or personal gain), or pass on to others, any information or documents provided by the Principal / Owner as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
  - 2.4. The Bidder(s) / Contractor(s) of foreign origin shall disclose the names and addresses of agents / representatives in India, if any. Similarly Bidder(s) / Contractor(s) of Indian

Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participate in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent/parallel tender for the same item.


- **2.5.** The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.
- **3.** The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- 4. The Bidder(s)/Contractor(s) will not, directly or through any other person or firm indulge in fraudulent practices means a wilful misrepresentation or omission of facts or submission of fake/forged documents in order to induce public official to act in reliance thereof, with the purpose of obtaining unjust advantage by or causing damage to justified interest of others and/or to influence the procurement process to the detriment of the Government interests.
- 5. The Bidder(s)/Contractor(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may befall upon a person, his/ her reputation or property to influence their participation in the tendering process).

#### **ARTICLE 3: CONSEQUENCES OF BREACH**

Without prejudice to any rights that may be available to the Principal / Owner under law or the Contract or its established policies and laid down procedures, the Principal/Owner shall have the following rights in case of breach of this Integrity Pact by the Bidder(s)/Contractor(s) and the Bidder/ Contractor accepts and undertakes to respect and uphold the Principal/Owner's absolute right:

- 1. If the Bidder(s)/Contractor(s), either before award or during execution of Contract has committed a transgression through a violation of Article 2 above or in any other form, such as to put his reliability or credibility in question, the Principal/Owner after giving 14 days' notice to the contractor shall have powers to disqualify the Bidder(s)/Contractor(s) from the Tender process or terminate/determine the Contract, if already executed or exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/Owner. Such exclusion may be forever or for a limited period as decided by the Principal/Owner.
- 2. Forfeiture of EMD/Performance Guarantee/Security Deposit: If the Principal/Owner has disqualified the Bidder(s) from the Tender process prior to the award of the Contract or terminated/determined the Contract or has accrued the right to terminate/determine the Contract according to Article 3(1), the Principal/Owner apart from exercising any legal rights that may have accrued to the Principal/Owner, may in its considered opinion forfeit the entire amount of Earnest Money Deposit, Performance Guarantee and Security Deposit of the Bidder/Contractor.

- 2. If the Bidder makes incorrect statement on this subject, he can be disqualified from the Tender process or action can be taken for banning of business dealings/ holiday listing of the Bidder/Contractor as deemed fit by the Principal/ Owner.



#### 1. GENERAL

- **1.1.** Location: Round the clock operation of 4 x 2000 KVA HT DG sets in IIT Delhi.
- 1.2. The work shall be executed as per CPWD General Specifications for Electrical Works Part-I (Int.) 2023, Part-II (Ext.) 2023, as amended upto date, relevant I.E. Rules, BIS/IEC and as per directions of Engineer-in-Charge. These additional specifications/conditions are to be read in conjunction with above and in case of variations; specifications given in these additional conditions shall apply. However, nothing extra shall be paid on account of these additional specification and conditions, as the same are to be read along with schedule of quantities for the work.
- **1.3.** The tenderer should in his own interest visit the site and get familiarize with the site conditions before tendering.
- **1.4.** No T&P shall be issued by the Department and nothing extra shall be paid on account of this.
- 2. COMMERCIAL CONDITIONS:
- **2.1. Type of contract:** The work to be awarded by this tender shall be treated as indivisible works contract.
- 2.2. Submission and opening of Tenders:
- **2.2.1.** The tender is in two parts:
  - 2.2.1.1. Part-I -EMD cum Technical Bid
  - 2.2.1.2. Part-II-Price Bid
- **2.3.** The tender shall be submitted online, duly completed as per NIT conditions within period of bid submission.
- **2.4.** The tenderers are advised not to deviate from the technical specifications / item, commercial terms and conditions of NIT like terms of payment, guarantee, arbitration clause, escalation etc.
- **2.5.** Technical cum un-priced commercial bid only shall be opened on the due date and time in the presence of tenderers or their authorized representative who wish to remain present.
- 2.6. Scrutiny/evaluation of the technical-cum-commercial bid shall be done by the department. In case, it is found that the technical-cum-commercial bid of a tenderer is not in line with NIT specifications/requirements and/or contains too many deviations, the department reserves the right to reject the technical bid of such firms(s) without making any reference to the tenderer(s).
- 2.7. Necessary clarifications required by the department shall have to be furnished by the tenderer within the time given by the department for the same. The tenderer will have to depute his representative to discuss with the officer(s) of the department as and when so desired. In case, in the opinion of the department a tenderer is taking undue long time in furnishing the desired clarifications, his bid will be rejected without making any reference.
- **2.8.** After obtaining clarification from all the tenders, the department will intimate the tenders whose EMD cum Technical Bid are acceptable.

- 2.9. The price bids of only those tenderers shall be opened whose technical bids are found to be technically acceptable. The time and date of opening of price bid shall be fixed after the EMD cum Technical Bid is accepted and intimated to them by post/Fax/e-mail.
- **2.10.** The department reserves the right to reject any or all the price bids and call for fresh prices/tenders as the case may be without assigning any reason.

#### 3. TERMS OF PAYMENTS

3.1. Running Account Payment shall be processed only after submission of document of payment of wages to the workers and submission of contribution receipts of EPF & ESI of workers as applicable. Bidder should note that necessary documents (PAN card, Cancelled cheque, GST Reg. proof and RTGS mandate form as per prescribed proforma of IIT Delhi) be submitted as soon as the work is awarded to them. Separate Contractor's Code shall be generated in IIT Delhi if the bidder is a new contractor to IIT Delhi ('Code' is perpetual in nature). Payment shall be processed after submission of Invoice and necessary documents / certificates (as mentioned in the NIT). There is a prevailing practice of pre-audit (for total tendered amount more than 6 lakhs) at IIT Delhi before releasing payment. Bidder shall have to comply all necessary documents as outlined in the Contract as to be desired by the Auditor and or by the Accountant. It may take one to two months in the whole process (from submission / acceptance of bill in CMB / MB by the contractor upto processing by Accounts section) to release payment subject to quick compliance of all submittals by the contractor. Applicable Taxes shall be got deducted from the bill as per prevailing orders of the Government. 'GST part of the bill' shall be released after submission of proof of payment of GST, i.e. B2B challan, etc. by the contractor.

#### 4. AWARD OF WORK

**4.1.** Work shall be awarded to the successful bidder only after concurrence of the **Auditor of the Internal Audit Section** of the IIT Delhi as per extant Rules of the Institute.

#### 5. SECURITY DEPOSIT

**5.1.** Security Deposit shall be deducted from each running bill and final bill to the extent of 2.5% of the gross amount payable. The security deposit shall be released on the expiry of guarantee/ Maintenance period stipulated in the contract i.e 01 Years.


#### 6. PERFORMANCE GUARANTEE

**6.1.** The successful tenderer shall submit an irrevocable performance guarantee of 5% of the tendered amount in addition to other deposit mentioned elsewhere in the contract for his proper performance of the contract agreement within 15 days of issue of letter of acceptance

of tender. 6.2. Income tax, GST, labour cess & other statutory deduction etc. shall be made at source as per the prevalent laws. The deduction of Security Deposit, Income Tax, etc., shall be done after

calculation for the above due payment as per clause 3 above and net payment shall reduce accordingly.

#### 7. RATES

**7.1.** The rates quoted by the tenderer, shall be firm and inclusive of all taxes (including works GST & labour cess), duties, levies, etc. and all charges for packing forwarding, insurance, freight and delivery, installation, testing and commissioning etc. at site including temporary construction of storage, risks overhead charges, general liabilities/ obligations.

#### 8. COMPLETENESS OF TENDER

#### 10. CARE OF THE BUILDING

**10.1.** Care shall be taken by the contractor while handling and installing the various equipment and components of the work to avoid damage to the building. He shall be responsible for repairing all damages and restoring the same to their original finish at his cost. He shall also remove at his cost all unwanted and waste material arising out of the installation from the site of work.

#### 11. COMPLETION PERIOD

**11.1.** The completion period indicated in the tender documents is for the entire work of planning, designing, approval of drawings etc, arrangement of materials & equipment, delivery at site including transportation, installation, testing, commissioning and handing over of the entire system to the satisfaction of the Engineer-in-charge.

#### 12. GUARANTEE

- 12.1. The contractor shall guarantee the entire Electrical Installation work as per specifications both for components and for system as a whole. All E.I work shall be guaranteed for One year from the date of commissioning against unsatisfactory performance and / or breakdown due to defective design, workmanship or material. The equipment or component, or any part thereof, so found defective during guarantee period shall be forthwith replaced free of cost to the satisfaction of the Engineer-in-Charge. In case it is felt by the department that undue delay is being caused by the contactor in doing this, the same will be got done by the department at the risk and cost of the contractor. The decision of Engineer-in-Charge in this regard shall be final & binding on the contractor.
- **12.2.** The tenderer shall guarantee among other things, the following:
- 12.2.1. Quality, strength and performance of the material used as per manufacturer's standards.
- 12.2.2. Safe mechanical and electrical stress on all part under all specified conditions of operation.
- 12.2.3. Satisfactory operation during the maintenance period.

#### 13. POWER SUPPLY

**13.1.** Power supply shall be made available by the department at one point near the site if required. Further, the arrangement for tapping power supply from this single point shall be made by the contractor.

#### 14. EXTENT OF WORK

14.1. The term complete installation shall not only mean major items of the plant and equipment's covered by the specification but all incidental sundry components necessary for complete execution and satisfactory performance of installation with all layout charts whether or not those have been mentioned in details in the tender documents in connection with this contract as this is a turnkey job.

#### 15. VALIDITY

#### 17. INDEMNITY

17.1. The successful tenderer shall at all times indemnify the department, consequent on this works contract. The successful tenderer shall be liable, in accordance with the Indian Law and Regulations for any accident occurring due to any cause and the contractor shall be responsible for any accident or damage incurred or claims arising there from during the period of erection, construction and putting into operation the equipment's and ancillary equipment under the supervision of the successful tenderer in so far as the latter is responsible. The successful tenderer shall also provide all insurance including third party insurance as may be necessary to cover the risk. No extra payment would be made to the successful tenderer on account of the above.



- 22. POLICY OF THE INSTITUTE

Contractor shall have to abide by the policy of the Institute with due diligence. Any violation on the part of the contractor shall be dealt with the extant rules of the Institute.

#### **SPECIAL TERMS AND CONDITIONS**

- 1. That it is expressly understood and agreed between the parties to this Agreement that the persons deployed by the contractor for the services mentioned above shall be the employees of the contractor for all intents and purposes and that the persons so deployed shall remain under the control and supervision of the contractor and in no case, shall a relationship of employer and employee between the said persons and the IITD shall accrue/arise implicitly or explicitly.
- 2. That on taking over the responsibility of providing Contractor's Worker, the contractor shall formulate the mechanism and duty assignment under intimation to the Engineer-in-charge. Subsequently, the contractor shall review work arrangement from time to time. The contractor shall further be bound by and carry out the directions/instructions given to him by the Engineer-in-charge in this respect from time to time.
- 3. That the Engineer-in-charge or any other person authorized by him shall be at liberty to carry out surprise check on the persons so deployed by the contractor in order to ensure that persons deployed by him are doing their duties.
- 4. That in case of the persons so deployed by the contractor does not come up to the mark or does not perform his/her duties properly or indulges in any unlawful activities or riots or disorderly conduct, the contractor shall immediately withdraw and take suitable action against such persons on the report of the Engineer-in-charge. Further, the contractor shall immediately replace the particular person so deployed on the demand of the Engineer-in-charge, in case of any of the aforesaid acts on the part of the said person.
- 5. That the contractor shall particularly abide by the provisions of Minimum Wages Act, 1948. Minimum wages shall be paid by the Agency / Contractor at the rate fixed by Central Govt. of India / IIT Delhi from time to time. Arrears, if due as result of increase in minimum wages would be reimbursed to the contractor on submission of proof of actual payment to the worker. In case of half yearly increase in Minimum wages by the Central Govt. of India, the contractor will submit copy of gazette notification to the Institute and the same may be considered by the Institute.
- 6. The contractor shall take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct or acts of his employees so deployed.
- 7. That the contractor shall deploy his persons in such a way that they get weekly rest. The working hours / leave, for which the work is taken from them, do not violate relevant provisions of the Act. The contractor shall in all dealings with the persons in his employment have due regard to all recognized festivals, days of rest and religious or other customs.
- 8. That the contractor shall keep the IITD indemnified against all claims whatsoever in respect of the employees deployed by the contractor. In case any employee of the contractor so deployed enters in dispute of any nature whatsoever, it will be the primarily responsibility of the contractor to contest the same. In case IITD is made party and is supposed to contest the case, IITD will be reimbursed for the actual expenses incurred towards Counsel Fee and other expenses which shall be paid in advance by the contractor to IITD on demand. Further, the contractor shall ensure that no financial or any other liability comes on IITD in this respect of any nature whatsoever and shall keep IITD indemnified in this respect.

- 9. The Work is to be carried out for stipulated period of time and may be extended further as desired by Engineer-in-charge.
- 10. Non Judicial stamp paper worth Rs.10/- (Ten Rupees only) will be submitted by the contractor which will have to be signed as token of acceptance.
- 11. Institute reserves the right to remove any person deployed by the firm, without assigning any reason/notice. This will be without prejudice to the right of the contractor to remove any of his own employees deployed in the Institute.
- 12. The contractor shall deploy 04 (Four) Nos. Highly Skilled Mechanic/ Operator should be passed ITI course in Electrician trade with 5 years experience having computer knowledge or Diploma in Electrical / Mechanical Engg, 02 (Two) Nos. Unskilled Helpers. The contractor shall take all reasonable precaution to prevent any unlawful, riotous or disorderly conduct or acts of his employees so deployed.
- 13. That the contractor shall submit detail of the names, parentage, residential address, age, educational qualifications, experiences, etc. with photocopies of documents of the persons deployed by him in the premises of the IIT Delhi for the purpose of proper identification and category of the employees of contractor deployed at various points/sections. He shall issue identity cards bearing their photographs / identification, etc. and such employees shall display their identity cards at the time of duty.
- 14. The contractor shall ensure that the persons are punctual and disciplined and remain vigilant in performance of their duty.
- 15. The Institute can increase or decrease the manpower requirement in case there is a further increase or decrease in area to be maintained. The increase/ decrease in manpower would accordingly affect the billing on pro-rata basis.
- 16. That the contractor shall be required to maintain **permanent Attendance Register in addition to Biometric Attendance (Face detection type provided by IIT Delhi)** at the IITD premises which shall be open for inspection and checking by the authorized officers of the IITD.
- 17. That the contractor shall make the payments of wages (not less than minimum wages as and when declared by the Central Govt. of India), etc. to persons so deployed on monthly basis through Bank Transfer / Electronic mode on or before 07<sup>th</sup> day of every month. Wages shall include bonus @ 8.33% of daily wage of the particular worker multiplied by number of days work actually performed by the worker in a particular month, which shall also be shown separately on the wage sheet of the worker. The monthly Bonus of the worker shall be paid as per Gol orders with up to date amendments prevailing in the particular month.
- 18. However the basic rates of wages as per latest notification by Central Govt. of India shall be considered as @ Rs. 1065/- per day for Highly Skilled Mechanic and @ Rs.805/- per day for Helper.
- 19. Attendance comparative sheet shall be prepared by the contractor and to be submitted to the Engineer-in-charge after completion of every month as per duty chart, desired days of duty of a particular worker allowing weekly off and actual days of duty performed by the said worker. Summation of the two columns should tie in normal case.

- 20. Recoveries of the absenteeism will be done on Basic Rate (+) Bonus (+) Contractor Profit (+) GST@18% (+) Labour Cess @ 1% and (+/-) rates quoted by the bidder in percentage (%) above / below the estimated cost.
- 21. A consolidated wage sheet containing the names of all workers so deployed by the contractor duly signed / acknowledged by the workers after disbursal of wages to be submitted to the Engineer-incharge every month. Proof of disbursal of wages to be submitted before claiming bill. The wage sheet shall contain mandatory fields as per following: (1) Sr. No., (2) Name of the worker, (3) Actual days of duty performed, (4) Total wages, (5) Bonus amount, (6) EPF contribution, (7) ESI contribution, (8) Total deductions, (9) Net wages received / disbursed, (10) Signature of the worker.
- 22. In case of any emergency/breakdown or in case of absentee of staff, the worker(s) on duty shall perform the extra duty to maintain the essential services. However, the total number of days in a month shall not exceed to the total number of staff in a particular category of post multiply by actual working days in that particular month.
- 23. In case of delay of payment of wages beyond 10 days as specified, IIT Delhi shall arrange for payment to the workers at the risk and cost of the contractor. Decision of the Engineer-in-charge in this regard shall be full & final and binding upon the contractor.
- 24. It would be the responsibility of contractor to arrange all permission/ approvals from all local bodies/statutory bodies and nothing extra shall be paid on account of this by the Institute.
- 25. The contractor shall deploy manpower in consultation of the Engineer-in-charge. Duty shall be assigned in different shifts by the Supervisor of the contractor and he will control and look after the duties of the operators. No shift shall be void of any operator and contractor shall arrange and substitute another operator in case of absence of any operator(s). However, department shall not pay any extra for this arrangement / substitution.
- 26. Log Books [as prescribed by Engineer-in-charge] and pens etc. required at site of operation of DG Sets shall be supplied and to be maintained at site by the contractor. Stationary items required for submitting daily/monthly reports, time to time shall be provided by the contractor.
- 27. Contractor shall provide following tools to each Mechanic grade staff within seven days from the start of the work: (1) One Plier and Screw drivers, (2) One tester and test lamp, (3) Set of wrenches /spanners (4) one adjustable spanner for repairing of switchgear etc. in Sub- Stations and receiving of the same got signed. Adequate cotton, dhoti, CRC, one broom shall be provided at every DG Sets as and when so required
- 28. EPF & ESI contribution in respect of workers shall be deposited with the authority concerned in time and employer's share shall be got reimbursed to the contractor by IIT Delhi on production of proof of deposition. The monthly EPF & ESI contribution of the worker shall be paid as per Gol order with up to date amendments applicable in the particular month. However, Income Tax as applicable shall be deducted from the EPF & ESI contribution reimbursement bill of the contractor.
- 29. Form IITD-8 [General Conditions of Contract] with correction slip shall form part of the contract.
- 30. Taxes shall be deducted from the bill of contractor as applicable.
- 31. Quoted rates shall be net rates inclusive of all taxes like GST etc.


