





Sub-Head:-Providing and Laying APP (Atactic Polypropylene Polymer) modified prefabricated five layer3mm thick water proofing membrane in SIT Building in Academic Area at IIT Delhi.

The Agreement made this --- day of ---- Two thousand and ---- between --- son of --- of ---- (hereinafter called the Guarantor of the one part) and B.O.G. IIT Delhi (hereinafter called Government of the other part)

WHEREAS THIS agreement is supplementary to a contract (hereinafter called the contract dated ---- and made between the GUARANTOR of the one part and the Government of the other part, whereby the contractor, inter alia, undertook to render the buildings and structures in the said contract recited completely water ad leak-proof.

AND WHEREAS GUARANTOR agreed to give a guarantee to the effect that the said structures will remain water and leak-proof for five years form the date of giving if water proofing treatment.

NOW THE GUARANTOR hereby guarantees that water proofing treatment given by him will render the structures completely leak-proof and the minimum life of such water proofing treatment shall be five years to be reckoned from the date after the maintenance period prescribed in the contract.

Provided that the guarantor will not be responsible for leakage caused by earthquake or structural defects or misuse of roof or alteration and for such purpose:
