# **INSTRUCTIONS FOR ONLINE BID SUBMISSION**

As per the directives of Department of Expenditure, this Quotation / tender document has been published on the Central Public Procurement Portal (URL:http://eprocure.gov.in/eprocure/app). The bidders are required to submit soft copies of their bids electronically on the CPP Portal, using valid Digital Signature Certificates. The instructions given below are meant to assist the bidders in registering on the CPP Portal, prepare their bids in accordance with the requirements and submitting their bids online on the CPP Portal.

## REGISTRATION

- 1) Bidders are required to enroll on the e-Procurement module of the Central Public Procurement Portal (URL:http://eprocure.gov.in/eprocure/app) by clicking on the link "Click here to Enroll". Enrolment on the CPP Portal is free of charge.
- 2) As part of the enrolment process, the bidders will be required to choose a unique username and assign a password for their accounts.
- 3) Bidders are advised to register their valid email address and mobile numbers as part of the registration process. These would be used for any communication from the CPP Portal.
- 4) Upon enrolment, the bidders will be required to register their valid Digital Signature Certificate (Class II or Class III Certificates with signing key usage) issued by any Certifying Authority recognized by CCA India (e.g. Sify / TCS / nCode / eMudhra etc.), with their profile.
- 5) Only one valid DSC should be registered by a bidder. Please note that the bidders are responsible to ensure that they do not lend their DSCs to others which may lead to misuse.
- 6) Bidder then logs in to the site through the secured log-in by entering their user ID / password and the password of the DSC / e-Token.

# SEARCHING FOR QUOTATION / TENDER DOCUMENTS

- 1) There are various search options built in the CPP Portal, to facilitate bidders to search active Quotations / Tender by several parameters. These parameters could include Quotation ID, organization name, location, date, value, etc. There is also an option of advanced search for Quotations, wherein the bidders may combine a number of search parameters such as organization name, form of contract, location, date, other keywords etc. to search for a Quotation published on the CPP Portal.
- 2) Once the bidders have selected the Quotations they are interested in, they may download the required documents / Quotation schedules. These Quotations can be moved to the respective 'My Quotations' folder. This would enable the CPP Portal to intimate the bidders through SMS / e-mail in case there is any corrigendum issued to the Quotation document.
- 3) The bidder should make a note of the unique Quotation ID assigned to Nos. Quotation / Tender, in case they want to obtain any clarification / help from the Helpdesk.

# **PREPARATION OF BIDS**

- 1) Bidder should take into account any corrigendum published on the Quotation document before submitting their bids.
- 2) Please go through the Quotation / Tender advertisement and the Quotation / Tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of Nos. of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the Quotation document / schedule and generally, they can be in PDF / XLS / RAR / DWF formats. Bid documents may be scanned with 100 dpi with black and white option.
- 4) To avoid the time and effort required in uploading the same set of standard documents which are required to be submitted as a part of every bid, a provision of uploading such standard documents (e.g. PAN card copy, annual reports, auditor certificates etc.) has been provided to the bidders. Bidders can use "My Space" area available to them to upload such documents. These documents may be directly submitted from the "My Space" area while submitting a bid, and need not be uploaded again and again. This will lead to a reduction in the time required for bid submission process.

# **SUBMISSION OF BIDS**

- 1) Bidder should log into the site well in advance for bid submission so that he/she upload the bid in time i.e. on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 2) The bidder has to digitally sign and upload the required bid documents one by one as indicated in the Quotation document.
- 3) Bidder has to select the payment option as "offline" to pay the Quotation fee / EMD as applicable and enter details of the instrument.
- 4) A standard BOQ format has been provided with the Quotation document to be filled by all the bidders. Bidders are requested to note that they should necessarily submit their financial bids in the format provided and no other format is acceptable. Bidders are required to download the BOQ file, open it and complete the white coloured (unprotected) cells with their respective financial quotes and other details (such as name of the bidder). No other cells should be changed. Once the details have been completed, the bidder should save it and submit it online, without changing the filename. If the BOQ file is found to be modified by the bidder, the bid will be rejected.

In some cases Financial Bids can be submitted in PDF format as well (in lieu of BOQ).

5) The server time (which is displayed on the bidders' dashboard) will be considered as the standard time for referencing the deadlines for submission of the bids by the bidders, opening of bids etc. The bidders should follow this time during bid submission.

- 6) All the documents being submitted by the bidders would be encrypted using PKI encryption techniques to ensure the secrecy of the data. The data entered cannot be viewed by unauthorized persons until the time of bid opening. The confidentiality of the bids is maintained using the secured Socket Layer 128 bit encryption technology. Data storage encryption of sensitive fields is done.
- 7) The uploaded Quotation documents become readable only after the Quotation opening by the authorized bid openers.
- 8) Upon the successful and timely submission of bids, the portal will give a successful bid submission message & a bid summary will be displayed with the bid no. and the date & time of submission of the bid with all other relevant details.
- 9) Kindly add scanned PDF of all relevant documents in a single PDF file of compliance sheet.

# ASSISTANCE TO BIDDERS

- 6. Completion certificates are required to be got issued by an officer not below the rank of **Executive Engineer** (**E**) of similar works completed by the Firm. The work experience certificates submitted by the bidders shall clearly indicate that:
  - a. The similar work executed shall be as per '4' above

AND WHEREAS the Principal/Owner values full compliance with all relevant laws of the land, rules, regulations, economic use of resources and of fairness/transparency in its relation with its Bidder(s) and Contractor(s).AND WHEREAS to meet the purpose aforesaid both the parties have agreed to enter into this Integrity Agreement (hereinafter referred to as "Integrity Pact" or "Pact"), the terms and conditions of which shall also be read as integral part and parcel of the Tender/Bid documents and Contract between the parties.

NOW, THEREFORE, in consideration of mutual covenants contained in this Pact, the parties hereby agree as follows and this Pact witnesses as under:

## Article 1: Commitment of the Principal / Owner

- 3) If the Principal/Owner obtains information on the conduct of any of its employees which is a criminal offence under the Indian Penal code (IPC)/Prevention of Corruption Act, 1988 (PoC Act) or is in violation of the principles herein mentioned or if there be a substantive suspicion in this regard, the Principal/Owner will inform the Chief Vigilance Officer and in addition can also initiate disciplinary actions as per its internal laid down policies and procedures.

# Article 2: Commitment of the Bidder(s) / Contractor(s)

- 1) It is required that Nos. Bidder/Contractor (including their respective officers, employees and agents) adhere to the highest ethical standards, and report to the Government / Department all suspected acts of **fraud or corruption or coercion or collusion** of which it has knowledge or becomes aware, during the tendering process and throughout the negotiation or award of a contract.
- 2) The Bidder(s)/Contractor(s) commit himself to take all measures necessary to prevent corruption. He commits himself to observe the following principles during his participation in the Tender process and during the Contract execution:

Similarly Bidder(s) / Contractor(s) of Indian Nationality shall disclose names and addresses of foreign agents/representatives, if any. Either the Indian agent on behalf of the foreign principal or the foreign principal directly could bid in a tender but not both. Further, in cases where an agent participate in a tender on behalf of one manufacturer, he shall not be allowed to quote on behalf of another manufacturer along with the first manufacturer in a subsequent/parallel tender for the same item.
- e) The Bidder(s)/Contractor(s) will, when presenting his bid, disclose any and all payments he has made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the Contract.
- 3) The Bidder(s)/Contractor(s) will not instigate third persons to commit offences outlined above or be an accessory to such offences.
- 4) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm indulge in fraudulent practices means a willful misrepresentation or omission of facts or submission of fake/forged documents in order to induce public official to act in reliance thereof, with the purpose of obtaining unjust advantage by or causing damage to justified interest of others and/or to influence the procurement process to the detriment of the Government interests.
- 5) The Bidder(s)/Contractor(s) will not, directly or through any other person or firm use Coercive Practices (means the act of obtaining something, compelling an action or influencing a decision through intimidation, threat or the use of force directly or indirectly, where potential or actual injury may befall upon a person, his/ her reputation or property to influence their participation in the tendering process).

# Article 3: Consequences of Breach

1) If the Bidder(s)/Contractor(s), either before award or during execution of Contract has committed a transgression through a violation of Article 2 above or in any other form, such as to put his reliability or credibility in question, the Principal/Owner after giving 14 days notice to the contractor shall have powers to disqualify the Bidder(s)/Contractor(s) from the Tender process or terminate/determine the Contract, if already executed or exclude the Bidder/Contractor from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of transgression and determined by the Principal/Owner. Such exclusion may be forever or for a limited period as decided by the Principal/Owner.

# Article 6: Duration of the Pact

For the sake of brevity, both the Parties agree that this Integrity Pact will have precedence over the Tender/Contact documents with regard any of the provisions covered under this Integrity Pact.

The work shall be carried out as per CPWD general Specifications for Electrical Works Part – I, II as amended upto date, relevant IE Rules and as per directions of Engineer-in-Charge. For electrical panels and other sub-stations equipments CPWD General Specifications for Electrical Works Part-IV (Sub-Stations) shall be applicable.
- **1.3** These additional specifications and conditions are to be read in conjunction with above and in case of variations, specifications given in the Additional specifications and conditions shall apply. However, nothing extra shall be paid on account of these as the same are to be read along with schedule of quantities for the work.
- **1.4** The tenderer should in his own interest visit the site and get familiarized with the site conditions before tendering.
- **1.5** No T&P shall be issued by the Department and nothing extra shall be paid on account of this.

# 2. COMMERCIAL CONDITIONS

#### Type of contract

The work to be awarded by this tender shall be treated as indivisible works contract.

## 4. SAFETY CODES AND LABOUR REGULATIONS

- (i) In respect of all labour employed directly or indirectly on the work for the performance of the contractor's part of work, the contractor at his own expense, will arrange for the safety provisions as per the statutory provisions, B.I.S. recommendations, factory act, workman's compensation act, CPWD code and instructions issued from time to time. Contractor shall have to abide by the policy of the Institute with due diligence. Any violation on the part of the contractor shall be dealt with the extant rules of the Institute.

# SPECIAL TERMS AND CONDITIONS

- 1. That it is expressly understood and agreed between the parties to this Agreement that the persons deployed by the contractor for the services mentioned above shall be the employees of the contractor for all intents and purposes and that the persons so deployed shall remain under the control and supervision of the contractor and in no case, shall a relationship of employer and employee between the said persons and the IITD shall accrue/arise implicitly or explicitly.
- 2. That on taking over the responsibility of providing Contractor's Worker, the contractor shall formulate the mechanism and duty assignment under intimation to the Engineer-in-charge. Subsequently, the contractor shall review work arrangement from time to time. The contractor shall further be bound by and carry out the directions/instructions given to him by the Engineer-in-charge in this respect from time to time.
- 3. That the Engineer-in-charge or any other person authorized by him shall be at liberty to carry out surprise check on the persons so deployed by the contractor in order to ensure that persons deployed by him are doing their duties.
- 4. That in case of the persons so deployed by the contractor does not come up to the mark or does not perform his/her duties properly or indulges in any unlawful activities or riots or disorderly conduct, the contractor shall immediately withdraw and take suitable action against such persons on the report of the Engineer-in-charge. Further, the contractor shall immediately replace the particular person so deployed on the demand of the Engineer-in-charge, in case of any of the aforesaid acts on the part of the said person.
- 5. That the contractor shall particularly abide by the provisions of Minimum Wages Act, 1948. Minimum wages shall be paid by the Agency / Contractor at the rate fixed by Delhi Govt. / IIT Delhi from time to time. Arrears, if due as result of increase in minimum wages would be reimbursed to the contractor on submission of proof of actual payment to the worker. In case of half yearly increase in Minimum wages by the Govt. of NCT of Delhi, the contractor will submit copy of gazette notification to the Institute and the same may be considered by the Institute.
- 6. The contractor shall take all reasonable precautions to prevent any unlawful, riotous or disorderly conduct or acts of his employees so deployed.
- 7. That the contractor shall deploy his persons in such a way that they get weekly rest. The working hours / leave, for which the work is taken from them, do not violate relevant provisions of the Act. The contractor shall in all dealings with the persons in his employment have due regard to all recognized festivals, days of rest and religious or other customs.
- 8. That the contractor shall keep the IITD indemnified against all claims whatsoever in respect of the employees deployed by the contractor. In case any employee of the contractor so deployed enters in dispute of any nature whatsoever, it will be the primarily responsibility of the contractor to contest the same. In case IITD is made party and is supposed to contest the case, IITD will be reimbursed for the actual expenses incurred towards Counsel Fee and other expenses which shall be paid in advance by the contractor to IITD on demand. Further, the contractor shall ensure that no financial or any other liability comes on IITD in this respect of any nature whatsoever and shall keep IITD indemnified in this respect.
- 9. The Work is to be carried out for stipulated period of time and may be extended further as desired by Engineer-in-charge.
- 10. Non Judicial stamp paper worth Rs.10/- (Ten Rupees only) will be submitted by the contractor which will have to be signed as token of acceptance.

- 11. Institute reserves the right to remove any person deployed by the firm, without assigning any reason/notice. This will be without prejudice to the right of the contractor to remove any of his own employees deployed in the Institute.
- 12. The contractor shall deploy 12 (Twelve) Nos. I.T.I. trained Mechanic/skilled man, 2 (Two) Nos. Semiskilled/Fitter/GittiMan and 13 (Thirteen) Nos. Helper in such a way that no shift and site (at various Sub-Stations) including Sundays & holidays shall be void of any operator. In addition to these, 01 (One) No. Graduate Computer Clerk having Basic Computer Knowledge such as MS Excel, MS Word, MS Power Point and e-mail etc with three years experience, 01 (One) No. Highly Skilled Technician having 2 years ITI in Electrician Trade with 08 years experience in 11KV Sub-Station works and 01 (One) No. Foreman having 3 years Diploma in Electrical Engineering with 8 years experience in 11KV Sub-Station work shall be provided. Foreman of the contractor will intimate the Engineer-in-charge on daily basis. He shall be vigilant and inspect every site and deploy manpower in sites displaying duty chart. Suitable substitute arrangement should be made by him / contractor if operator[s] / helper[s] remain[s] on leave / absent / fail[s] to attend duty. No extra payment shall be made by the IITD in this regard.
- 13. That the contractor shall submit detail of the names, parentage, residential address, age, educational qualifications, experiences, etc. with photocopies of documents of the persons deployed by him in the premises of the IIT Delhi for the purpose of proper identification and category of the employees of contractor deployed at various points/sections. He shall issue identity cards bearing their photographs / identification, etc. and such employees shall display their identity cards at the time of duty.
- 14. The contractor shall ensure that the persons are punctual and disciplined and remain vigilant in performance of their duty.
- 15. The Institute can increase or decrease the manpower requirement in case there is a further increase or decrease in area to be maintained. The increase/ decrease in manpower would accordingly affect the billing on pro-rata basis.
- 16. That the contractor shall be required to maintain **permanent Attendance Register in addition to Biometric Attendance (Face detection type provided by IIT Delhi)** at the IITD premises which shall be open for inspection and checking by the authorized officers of the IITD.
- 17. That the contractor shall make the payments of wages (not less than minimum wages as and when declared by the Govt. of NCT Delhi), etc. to persons so deployed on monthly basis through Bank Transfer / Electronic mode on or before 07<sup>th</sup> day of every month. Wages shall include bonus @ 8.33% of daily wage of the particular worker multiplied by number of days work actually performed by the worker in a particular month, which shall also be shown separately on the wage sheet of the worker.
- 18. However the basic rates of wages as per latest notification by Govt. of NCT Delhi shall be considered as @ Rs. 689/- per day for Mechanic / Skilled Man, @ Rs. 626/- per day for Semiskilled / Fitter / Gittiman, @ Rs.569/- per day for Helper and @ Rs.887/- per day for Graduate Computer Clerk.
- 19. The rate of Highly Skilled Technician and Foreman is @ Rs. 1100/- per day (fixed throughout the contract period).
- 20. Attendance comparative sheet shall be prepared by the contractor and to be submitted to the Engineer-in-charge after completion of every month as per duty chart, desired days of duty of a particular worker allowing weekly off and actual days of duty performed by the said worker. Summation of the two columns should tie in normal case. Falling short of days of attendance from desired days of attendance shall be got deducted from the bill of the contractor at the rate of the daily

- 21. A consolidated wage sheet containing the names of all workers so deployed by the contractor duly signed / acknowledged by the workers after disbursal of wages to be submitted to the Engineer-incharge every month. Proof of disbursal of wages to be submitted before claiming bill. The wage sheet shall contain mandatory fields as per following: (1) Sr. No., (2) Name of the worker,(3) Actual days of duty performed, (4) Total wages, (5) Bonus amount, (6) EPF contribution, (7) ESI contribution, (8) Total deductions, (9) Net wages received / disbursed, (10) Signature of the worker.
- 22. The work shall be carried out in four shifts i.e. General Shift, Morning Shift, Evening Shift and Night Shift. The working hours for all the staff excluding Graduate Computer Clerks shall be as per six days a week, whereas the working hours for Graduates Computer Clerks shall be as per five days a week as per Govt. rule and regulations.
- 23. In case of any emergency/breakdown or in case of absentee of staff, the worker(s) on duty shall perform the extra duty to maintain the essential services. However, the total number of days in a month shall not exceed to the total number of staff in a particular category of post multiply by actual working days in that particular month.
- 24. In case of delay of payment of wages beyond 10 days as specified, IIT Delhi shall arrange for payment to the workers at the risk and cost of the contractor. Decision of the Engineer-in-charge in this regard shall be full & final and binding upon the contractor.
- 25. It would be the responsibility of contractor to arrange all permission/ approvals from all local bodies/statutory bodies and nothing extra shall be paid on account of this by the Institute.
- 26. Log Books [as prescribed by Engineer-in-charge] and pens required at site of operation of Sub-Station shall be supplied and to be maintained at site by the contractor. Stationary items required for submitting daily/monthly reports, time to time shall be provided by the contractor.

Contractor shall provide following tools to each Mechanic grade staff within seven days from the start of the work : (1) One Plier and Screw drivers, (2) One tester and test lamp , (3) Set of wrenches /spanners (4) one adjustable spanner for repairing of switchgear etc. in Sub-Stations and receiving of the same to got signed. Adequate cotton, dhoti, CRC, one broom shall be provided at every sub-station as and when so required.
- 29. EPF & ESI contribution in respect of workers shall be deposited with the authority concerned in time and employer's share shall be got reimbursed to the contractor by IIT Delhi on production of proof of deposition. However, Income Tax as applicable shall be deducted from the EPF & ESI contribution reimbursement bill of the contractor.
- 30. Form IITD-8 [General Conditions of Contract] with correction slip shall form part of the contract.
- 31. Taxes shall be deducted from the bill of contractor as applicable.
- 32. Quoted rates shall be net rates inclusive of all taxes like GST etc.
